# The President's Message

Compatriots,

On February 27, 1968, the world of television journalism changed forever.

Walter Cronkite, anchor of the CBS Evening News, hosted a CBS News Special Report regarding the Vietnam War. During his three-minute closing, he did what neither he, nor any other national television journalist, had ever done before: he gave his own opinion about the war.

"We've been too often disappointed by the optimism of the American leaders, both in Vietnam and Washington, to have faith any longer in the silver linings they find in the darkest clouds. For it seems now more certain than ever that the bloody experience of Vietnam will end in a stalemate ..."

"But it is increasingly clear to this reporter that the only rational way out then will be to negotiate, not as victors, but as an honorable people who lived up to their pledge to defend democracy, and did the best they could."

President Lyndon Johnson, watching live in The White House, reportedly then turned to aides and said, "If I've lost Cronkite, I've lost Middle America."

Cronkite's comments, and their impact on American views about the Vietnam War, would rattle the Journalism industry.

Thereafter, the line between hard-fact, down-themiddle journalistic reporting and "viewpoint" news has become more blurred.

Networks, newspapers, and websites are no longer mostly known by their journalistic integrity, but by their bias. Tell me who you're getting your news from ... and I can pin down your political views. We all can.

"Viewpoint" news has been with us since the American Revolution. Pamphlets that supported the Revolution included Thomas Paine's "Common Sense" and John Adams's "Thoughts on Government." Pamphlets against the Revolution included Thomas Chandler's "A Friendly Address To All Reasonable Americans" and Charles Inglis's "The Deceiver Unmasked".

You may recall that George Washington, during his second term, was bedeviled by constant negative press. Although he denied it publicly at the time, Secretary of State Thomas Jefferson was a key figure behind the scenes in establishing the opposition presses. Even then, journalists were being influenced by politics.

Who should we believe today? Your guess is as good as mine. But perhaps we should take comfort in William Shakespeare's line from 1596's "The Merchant of Venice": "The Truth Will Out."

I look forward to seeing you at our 1/23/18 General Membership Meeting. Thank you for being a member of the Capt. Barron Chapter.

### John Dickinson 11/8/1732 - 2/14/1808)

One of Founding Fathers Of the United States, was a solicitor and politician from Philadelphia, Pennsylvania and Wilmington, Delaware

Dickinson was known as the "Penman of the Revolution" for his twelve *Letters from a Farmer in Pennsylvania*, published individually in 1767 and 1768. As a member of the First Continental Congress, where he was a signee to the Continental Association, Dickinson drafted most of the 1774 Petition to the King, and then as a member of the Second Continental Congress wrote the 1775 Olive Branch Petition, two attempts to negotiate with King George III of Great Britain. When these failed, he reworked Thomas Jefferson's language and wrote the final draft of the 1775 "Declaration of the Causes and Necessity of Taking Up Arms". When Congress then decided to seek independence, Dickinson served on the committee that wrote the Model Treaty, and then wrote the first draft of the 1776–1777 Articles of Confederation and Perpetual Union.

Dickinson later served as President of the 1786 Annapolis Convention, which called for the Constitutional Convention of 1787, which Dickinson then attended as a delegate from Delaware.

He also wrote "The Liberty Song" in 1768, was a militia officer during the American Revolution, President of Delaware, President of Pennsylvania, and was among the wealthiest men in the British American colonies.

When the Continental Congress began the debate on the Declaration of Independence on July 1, 1776, Dickinson reiterated his opposition to declaring independence at that time. Dickinson believed that Congress should complete the Articles of Confederation and secure a foreign alliance before issuing a declaration. Dickinson also objected to violence as a means for resolving the dispute. He abstained or absented himself from the votes on July 2 that declared independence and absented himself again from voting on the wording of the formal Declaration on July 4. Dickinson understood the implications of his refusal to vote stating, "My conduct this day, I expect will give the finishing blow to my once too great and, my integrity considered, now too diminished popularity." Dickinson refused to sign

the Declaration and since a proposal had been brought forth and carried that stated, "for our mutual security and protection," no man could remain in Congress without signing, Dickinson voluntarily left and joined the Pennsylvania militia.

Following the Declaration of Independence, Dickinson was given the rank of brigadier general in the Pennsylvania militia, known as the Associators. He led 10,000 soldiers to Elizabeth, New Jersey, to protect that area against British attack from Staten Island. But because of his unpopular opinion on independence, two junior officers were promoted above him.

Dickinson prepared the first draft of the Articles of Confederation in 1776, after others had ratified the Declaration of Independence over his objection that it would lead to violence, and to follow through on his view that the colonies would need a governing document to survive war against them.

On January 18, 1779, Dickinson, as President of Delaware, was appointed to be a delegate for Delaware to the Continental Congress. During this term he signed the Articles of Confederation, having in 1776 authored their first draft while serving in the Continental Congress as a delegate from Pennsylvania.

In 1784, Dickinson and Mary Norris Dickinson bequeathed much of their combined library to John and Mary's College, named in their honor by its founder Benjamin Rush, and later renamed Dickinson College. The Dickinsons also donated 500 acres in Carlisle, Pennsylvania, land originally inherited and managed by Mary Norris, to the new college. Together with his wife, Mary Norris Dickinson, John Dickinson is also the namesake of the Dickinson School of Law of Pennsylvania State University and the University of Delaware's Dickinson Complex. John Dickinson High School was opened/dedicated in 1959 as part of the public schools in northern Delaware.

John Dickinson died at Wilmington, Delaware and was buried in the Friends Burial Ground. In an original copy of a letter discovered November 2009 from Thomas Jefferson to Joseph Bringhurst, caretaker of Dickinson in his later years, Jefferson responded to news of Dickinson's death:

"A more estimable man, or truer patriot, could not have left us. Among the first of the advocates for the rights of his country when assailed by Great Britain, he continued to the last the orthodox advocate of the true principles of our new government and his name will be consecrated in history as one of the great worthies of the revolution."

## **Treaty of Paris**



Done at Paris, this third day of September in the year of our Lord, one thousand seven hundred and eighty-three.

The Definitive Treaty of Peace 1783

### **Treaty of Paris**

Done at Paris, this third day of September in the year of our Lord, one thousand seven hundred and eighty-three.

#### Article 6:

That there shall be no future confiscations made nor any prosecutions commenced against any person or persons for, or by reason of, the part which he or they may have taken in the present war, and that no person shall on that account suffer any future loss or damage, either in his person, liberty, or property; and that those who may be in confinement on such charges at the time of the ratification of the treaty in America shall be immediately set at liberty, and the prosecutions so commenced be discontinued.

#### Article 7:

There shall be a firm and perpetual peace between his Brittanic Majesty and **the said states**, and between the subjects of the one and the citizens of the other, wherefore all hostilities both by sea and land shall from henceforth cease. All prisoners on both sides shall be set at liberty, and his Brittanic Majesty shall with all convenient speed, and without causing any destruction, or carrying away any Negroes or other property of the American inhabitants, withdraw all his armies, garrisons, and fleets from the said United States, and from every post, place, and harbor within the same; leaving in all fortifications, the American artilery that may be therein; and shall also order and cause all archives, records, deeds, and papers belonging to any of the said states, or their citizens, which in the course of the war may have fallen into the hands of his officers, to be forthwith restored and delivered to the proper states and persons to whom they belong.

#### Article 8:

The navigation of the river Mississippi, from its source to the ocean, shall forever remain free and open to the subjects of Great Britain and the citizens of the United States.

#### Article 9:

In case it should so happen that any place or territory belonging to Great Britain or to the United States should have been

conquered by the arms of either from the other before the arrival of the said Provisional Articles in America, it is agreed that the same shall be restored without difficulty and without requiring any compensation.

#### Article 10:

The solemn ratifications of the present treaty expedited in good and due form shall be exchanged between the contracting parties in the space of six months or sooner, if possible, to be computed from the day of the signatures of the present treaty. In witness whereof we the undersigned, their ministers plenipotentiary, have in their name and in virtue of our full powers, signed with our hands the present definitive treaty and caused the seals of our arms to be affixed thereto.

Done at Paris, this third day of September in the year of our Lord, one thousand seven hundred and eighty-three.

Editorial Comment:

Following is Article 1 – *repeated* – which reveals that the Treaty was between His Brittanic Majesty and **TWELVE** states...**Delaware was not included in the Treaty.** 

Article 1: His Brittanic Majesty acknowledges the said United States, viz., New Hampshire, Massachusetts Bay, Rhode Island and Providence Plantations, Connecticut, New York, New Jersey, Pennsylvania, Maryland, Virginia, North Carolina, South Carolina and Georgia, **to be free sovereign and independent states**, that he treats with them as such, and for himself, his heirs, and successors, relinquishes all claims to the government, propriety, and territorial rights of the same and every part thereof.

Article 1 and Article 7 demonstrate that the **Treaty was between his Brittanic Majesty and "the said states" – "free sovereign and independent states"** rather than between his Brittanic Majesty the United States.
