

tain John Dean who had been ordered by Colo- and had dinner. nel Jameson to put together the group of six men to guard the road north of Tarrytown charged with keeping supplies from reaching the British in New York City.

Wart and several other men had dropped by Ja- than it already was. cob Romer's home for breakfast. When they left out that morning, three of the men, including Isaac, went just north of Tarrytown and the others set up about a half mile away. Later that morning a lone rider came upon the three men. He first thought they were British and offered money to be escorted to the British front. They told him they were Americans and that he was under arrest. He then handed them a pass from Benedict Arnold. This raised even more suspicion, so they searched him, finding documents in his boots relating to fortifications at West Point. He then offered them any amount of money or provisions they could name to be taken to West Point. They turned that down and did what they were supposed to do. They took him to the rest of their group who then transported their prisoner to Colonel John Jameson in North Castle, where it was eventu-

> 37 years after the fact, in 1817, John Paulding, one of the three men, came before Congress with a request for a raise in his pension. Then Senator Benjamin Tallmadge made a statement before Congress that caused a firestorm of controversy. In his argument to deny the request he told Congress that Major John Andre had told him that the three men were merely robbing him. That statement set in motion an investigation of the events and after many sworn statements, interviews and hearings the three men were vindicated, and in 1853 a 30-foot monument was erected in their honor on the site of the capture just north of Tarrytown.

> Isaac Van Wart was awarded one of the first three Congressionally awarded medals at the direction of George Washington.

#### **REGISTRAR'S NOTE**

#### **MEMORIAL MEMBERSHIPS**

- 1. A Memorial Member is a male who is a deceased close relative (within two generations) of an SAR member and whose application is based on (most of) the same lineage as that SAR member.
- 2. The filing of a Memorial Membership is only available to active SAR members.
- 3. A copy of the birth and death certificate as well as any other necessary proof documents to link the application to the previously approved application will be required.
- 4. The Memorial Member pays no dues.
- 5. The Memorial Member application needs two sponsors just like any New Member application.
- 6. The living SAR Member relative of the prospective Memorial Member will submit his relative's application and he may also be the First Line Sponsor.
- 7. In the space on the application for age, calculate the deceased member's age at the time of the application.
- 8. The SAR Member submitting the Memorial Application will us his Address, phone number and Email info.
- 9. The Memorial Application is to be signed by the living SAR Member relative "for" the deceased applicant.
