Barbara Magerkurth – National LASAR – Special Hello to Texas Girls from Washington – welcome and encourage everyone to go to National Congress being held in Atlanta July 4-8, 2009.

Roster sent around for everyone to sign in and make any changes to name, email, address, etc.

Motion to accept the meeting minutes as posted on website from the October 2008 Tyler BOM Meeting – Connie Barker made motion – Approved unanimously by group.

## **Treasurer's Report** – Barbara Baker

Dues paying time – email, letter sent to all members reminding them dues due annually at the State Conference - \$5.00 annually – checks to LATXSSAR or cash in envelope w/ name on outside so know who is paying their dues.

Treasurer's Report not available during the meeting but emailed subsequent to the meeting and provided the following:

As of March 1, the bank account was moved to North Dallas Bank & Trust Company – this bank would have no fee charges and interest will be paid on the account. Chase account has not been closed yet as there is need for a resolution from this group for Treasurer, Barbara Baker, to have the authority to do so.

Motion made by June Everheart and 2<sup>nd</sup> by Linda Edwards to authorize Barbara Baker to close the account currently held at Chase. Motion passed unanimously.

At the time of the meeting \$2,101.00 collected with an additional \$152 collected at the banquet for a grand total of \$2,253.00 collected on raffle sales for the quilt. Barbara made a recommendation that expenses for the quilt be paid from the general fund and that all funds received from ticket sales go to the Patriot Fund Expense. Mary Ann Bentley made motion to accept recommendation. Motion 2<sup>nd</sup> and passed unanimously. As tickets will continue to be sold throughout the day, Linda Edwards moved that a check in the amount of \$2000 be presented to TXSSAR at tonight's banquet, the remainder to be forwarded to the TXSSAR Treasurer when all ticket sales are accounted for, 2<sup>nd</sup> by Henrietta Slagle, motion passed unanimously. Barbara Baker will mail an additional check to new TXSSAR treasurer, for all funds remaining in the account from the quilt sale above the \$2,000.00 presented tonight.

# Registrar's Report – Barbara Baker

During this meeting current membership was -145.

24 people responded by mailing checks for dues – 3 new members

1 more new life member. Subsequent to the meeting a report was received from Barbara indicating there are 109 active members on the roster whom had paid their dues for 2007 and 78 inactive members on the roster whom had not paid their dues in 2007.

June Everhart moved to approve budget as submitted. Betty Presley seconded the motion. Motion was approved unanimously.

### **New Business**

Robin Butler spoke regarding National Congress and brought greetings from the NLASAR– issuing a formal invitation to Atlanta – a great place for Civil War History – Stone Mountain and the Cyclorama.

Suzanne Fife reported that Harry and she had a great year traveling around Texas. Wishes Mickey and Tom best in carrying on new adventures.

Discussion held on an amendment to have LATXSSAR absorb expenses related to BOM's and State Conventions with agreement to offer to pay expenses related to State Meetings as needed. Motion made by Sandi Craig and Wanda White 2<sup>nd</sup> the motion that we have an amendment offering to pay expenses as needed for costs associated with food, drinks, etc. Motion carried unanimously.

Larry Stevens is going to take over publishing the Compatriot Newsletter – Discussion was held as to whether LATXSSAR would like to submit information to be included.

Recommendation was made by June Everhart to send it through a specific person to get it to Larry Stevens for print. It was agreed that the logical person for this would be Barbara Stevens.
