NOTES/COMMENTS:

- 1) The bottom line is that the Chapter still seems to be in reasonably good shape finance wise.
- 2) The primary source of receipts for the Chapter continues to be payments for dinners AND likewise the lion's share of the Chapter's disbursements goes to paying for the meals at our dinner meetings. The huge deficit in receipts for dinners may cause concern at first but when compared to the actual dinner disbursements the receipts seem to be right on track (a 5.5% overage of receipts which is about what we had hoped for). It is believed that the overall numbers are down from previous years due to fewer members/guests attending the dinner meetings - an area we should probably work on in the coming year.
- 3) We seem to have estimated the TxSSAR rebates pretty well (overestimated only about 7.5%) but we seemed to be overly optomistic on our estimates of the other receipts.
- 4) It is noteworthy that we have not had any donations made to the Chapter this year, perhaps this is another area to work on in the new year.
- 5) Our largest budget disbursement overage is in the purchase of medals however since a portion of these was to build our inventory stockpile the overage was not detrimental
- to the Chapter's overall asset situation. 6) A number of budgeted disbursement items have not incurred any expense so fur. It is assumed that some of these outlays will be made in the next thirty (30) days or will be
- deferred to the 2001-2002 Chapter year. 7) The certificate of deposit continues to grow as the interest on it is rolled back into it. We will probably have to either let it grow further OR solicit additional donations (specifically designated for it) before we can initiate the scholarship award(s) that we have previously discussed.
- 8) Some of our favorite restaurants for holding meetings are altering the conditions for the use of their facilities which will likely impact the cost of future dinners.
