

HISTORY 101 - As you may recall, in last year's newsletter I ran a series of articles listing key books - available locally at the Clayton Library - that are useful in proving the patriotic service of your ancestors. This year, I'd like to run through a number of topics (of interest to me and hopefully to y'all) arrising from the Revolutionary War. In this issue, I'd like to point out some interesting aspects of the coinage of the new nation. First, one must realize that coins were crucial to trade in the United States - credit cards were still a long way off, paper money was typically accepted only by people who were familiar with the bank that had issued the money or if the bank was local and they could personally present the banknote at the bank and receive in exchange hard currency (that is to say "coins") for it. Second, essentially in all small scale trade outside their local area (and in particular foreign trade) the seller demanded payment again in hard currency. And third, in that era the value of the coinage was such that the vast majority of day-to-day items that people typically purchased could be readily valued in a few coins. Our founding fathers established a metric system of currency with 100 cents ("centi-" being the Latin prefix for the hundredth portion of something) to the dollar. Having done so though, it would not be until well after the Revolutionary war was over that the new nation would actually set about the task of producing significant quantities of coinage. With the war being over in 1783, it was not until 1793 that the first pennies and half pennies were minted. And even then the quantities being minted were insufficient to meet the needs of the populace (there were only about 110 thousand of the 1793 penny minted in eight varieties and of the rarest variety only four specimens are known to have survived to modern times). Silver coins began being produced in 1794 including the half dime (silver 5 cent piece), the half dollar, and the silver dollar. But again, only in very small numbers (only 1,758 of the 1794 silver dollars were produced). To meet the demand for hard currency, coinage from many other nations saw widespread use in the United States. The silver coinage from the Spanish colonies in Central and South America saw extensive circulation (primarily due to its ready availability and its similarity in size to the existing US silver coins). Coins from Great Britain were also fairly common in spite of the complexity of their values (two farthings = a ha'penny, two pennies = one tuppence, three pennies = one trupence, two tuppence = one groat, two truppence = one sixpence, two sixpence = one shilling, two shillings = one florin, one florin plus a sixpence = half a crown, five shillings = a crown, and so on...). And to a lesser degree coins of other nations (eg the Netherlands, France, and the German States) circulated. It wasn't until 1837, fifty-four years after the war, that the US government cranked up the production of coins to the point that the foreign pieces started disappearing from service and most transactions involved American coins.

MINUTES OF 15 MARCH 2001 "MEMBERS ONLY DINNER MEETING:"

On Thursday - March 15, 2001 - the PineyWoods Chapter #51 of the TxSSAR held a "members only dinner meeting" at the new "Heritage Center" in Kingwood, Texas. Eighteen members and one guest were in attendance at 7:17PM when 2000-01 Chapter President Bob McKenna called the meeting to order. Following the invocation, the pledge of allegiance, and the SAR pledge, Bob introduced our guest speaker - B. Rice Aston - and a new member to the Chapter - Compatriot John Pritchett. Following dinner (turkey and ham buffet from Boston Market) Bob reconvened the meeting at 8:08 and proceeded to the officers' reports. In the absence of Mike Culbertson, John Albright presented the minutes of the 15 FEB meeting. A motion was made and seconded to accept the minutes as presented and passed unanimously. James Jones presented the treasurer's report which was similarly accepted. In Allan Henshaw's chancellor's report he noted that \$52 had been budgeted for contribution to the state society's Patriot Fund but had not as yet been paid. He noted that that fund is key to the state's activities and the members present agreed that the commitment should be met. In the genealogist's report, Kim Morton noted that the Chapter had been awarded the E. A. Limmer, Jr. Award for the Texas Chapter that had submitted the most supplemental applications in the past year. He noted that this is the fourth time that PineyWoods has held the award: 1994-5, 1995-6, 1996-7, and now 2000-1. Kim also noted that Tom Green of our Chapter is running for the position of genealogist in the Texas State Society. The registrar had no report to make. In Worthy Warnack's historian report, he noted 16 AUG 2001 - officer only mtg. that the Chapter scrapbook for 2000-01 was nearly complete and indicated that anyone who had items to be included therein should get them to him soon. Worthy also noted that there were plenty of materials left to use as a starting point in assembling the Chapter's 2001-02 scrap-book. In the absence of Rev. Harper, Bernie Balser presented the Chaplin's report. He noted that besides the E. A. Limmer Award, the Chapter had also been awarded the Ross L. Shipman award for the best chapter single-sheet newsletter in Texas for the year 2000-01 (don't ask me how this duty fell to the chaplin, perhaps it was through prayer that the awards were swayed?) Bernie displayed the plaques that the Chapter will possess and display for the year and said that he would have the Chapter's name engraved in the appropriate places on the plaques. Bob McKenna then asked B. Rice Aston to oversee the swearing in of the new officers which was done according to SAR procedures. Mr. Aston then spoke at length on where he sees the state and national societies going over the next few years (he is running for the position of Secretary General of the National Society this year). Following his presentation, Bobby Smith took over the meeting as the new Chapter President and asked if there was any old business. There being none he then asked about new business. Tom Green spoke on the favorable response to a project 15 AUG 2002 - officer only mtg. of presenting framed pictures of George Washington to selective schools. He indicated the cost was about \$85 per picture. It was decided to discuss this further at a future meeting. Tom Green noted that since the Newsletter had won top honors last year John Albright should be 21 NOV 2002 - dinner meeting drafted to edit it another year. A motion was made (when I find out by who...), seconded, and passed almost unanimously. Jim Jones indicated that the Chapter must act to change the signatures on the checking account for the new officers. The motion was made, seconded and passed.
