

Compatriots' Patriots

Jeffrey M. Meadows #142213-TX#7350 6TH Great Grandfather Major William Lightfoot

William Lightfoot was the youngest son of Colonel Goodrich Lightfoot (born about 1682 in New Kent Co., Virginia) and Mary Chew (born Dec. 1698 in Calvert County, Maryland) of Orange County, VA. William Lightfoot was born about 1720 in New Kent County, VA. On 23 November 1744, he came into Court and made the choice of Edward Spencer, Gent., as his guardian. Before 1749 he moved to Richmond County, VA and had married Elizabeth Barrow, daughter of Edward and Elizabeth Minor Barrow on 5 March 1746 in Westmoreland County. William Lightfoot may have been married twice since his children were born over a period of more than twenty-five years, but only one record has been found which names his wife.

William Lightfoot was a vestryman of St. Mark's Parish, Virginia, from June 1752 until 1758, when he settled in Broomfield Parish, within the present county of Madison. He is mentioned a number of times in the court minute book of Culpeper County in 1763 and in 1764, Captain William Lightfoot was listed with 200 acres on the Culpeper County rent roll. In 1787 William Lightfoot was taxed for 215 acres and in 1788 and 1789 for 211 acres. In 1790, 1791 and 1793, his son Goodrich Lightfoot paid the taxes on this same tract which was then entered as 219 acres. The land was sold in 1793 and in 1795 he moved with his sons, John, Edward and his daughter Frances to Jefferson County, KY. William died at the home of his daughter Mildred Nabb in Jefferson County Kentucky, on 5 November 1805. He is buried at the entrance to the Louisville Country Club, as this land was part of his 4,569 acre land grant to Kentucky.

He served as an Ensign in the militia under Colonel Thomas Slaughter, his uncle, in 1756, and marched "against the Indians above Winchester," where the troops were under the command of Colonel George Washington. In 1774, Colonel Slaughter petitioned Lord Dunmore for grants of land for himself and the officers who served under him, including William Lightfoot." William Lightfoot's will was recorded in Pendleton County, KY in 1799; will written 20 Aug 1799 - recorded 22 Aug 1799.

His major contribution to the Revolutionary War cause was that he gave the Virginia Continental Line (paid at Culpeper County, VA) £24,141,13.4 as a gift, not to be repaid.

I descend from the oldest child, John Barrow Lightfoot and his wife Lavina D. Duncan. Research on 5th Great Grandfather, Captain John B. Lightfoot of Culpeper Co., VA continues.
