Our Veteran's Day Celebration broke new ground as the Robert Rankin Chapter held a joint meeting with the VFW Post 9182 out of Katy, Texas. The VFW program, open to the public, was in three parts that included an overview of the VFW and then remembrances from veterans of WWII and Korea.

Retired Col. Michael Mastrangelo, Commander of Katy VFW Post 9182, noted that the goals of the VFW are fraternal, patriotic, historical, and educational.

Specifically this includes a charge to strengthen comradeship among its members and to assist comrades. It is also to honor our dead and to assist their widows and orphans. Included as well is ongoing service to the community, educating the public and advocating the welfare of the U.S. military.

E.D. Christensen, a Lieutenant Colonel in the Army and in the photo below, served as a pilot of the P-38 Lightning fighter-bomber, shown left.



Ed was a member of the 367th fighter group which was stationed out of Goxhill, England. Christensen flew over 70 missions in his P-38, nicknamed Fighting Badger. His missions included flying sub patrol, fighter sweeps, dive-bombing missions, and top cover for bombers.

"I flew top cover for bombers that attacked ball-bearing plants, synthetic oil refineries, and the aircraft factories." Christensen was credited with destroying 3 ½ aircrafts and had more that were unconfirmed, as well as hundreds of tanks, trucks, locomotives and other structures.

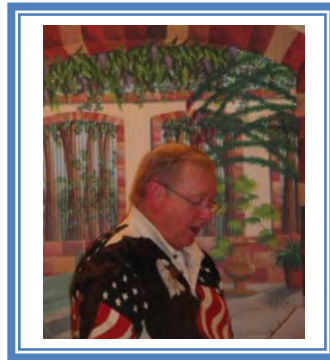
Terry is to the left of Tom Jackson in the photo above and to the right of Rankin President Bobby Smith in the photo below.

Newsletters editors are encouraged to display both the NSSAR and state logos. The newer state logo, which is now displayed, depicts the militiamen looking inward or to the left, as compared to the earlier logo, which depicted the militiamen looking to the right. The national logo is merely one of a number of different approved logos. Most periodicals number the issue within each year. **This was not done because the number of issues change from year to year thus numbering them sequentially makes for easier reference.**

The name of the newsletter is a different matter. Some would argue that the name should not be stodgy, dull, traditional, and boring, but rather modern, clever and catchy. National suggests that the name be reflective of the intent of the editor. **The decision was made that the newsletter reflect the chapter meetings as well as activities in which members participated. Terry Richardson Robert Rankin Chapter

Personal: Terry was born in Cambridge, Nebraska just before the 1940's. He has been married to his wife Lynda for fifty years and they have two sons, Eric and Brad, and six grandchildren. Both sons and grandsons, Taylor and Trevor, have submitted their applications to the SAR.

Education:

Terry graduated from Indianola Public High School in Indianola, Nebraska, in 1958. He earned a B.A. and M.S. Degree from Kearney State College, Kearney, Nebraska, in 1962 and 1966, respectively. He did graduate study at Ohio State University, Kent State University, Pittsburg State University, during 1968, 1969, and 1970, respectively. He earned his Ed.S. from Pittsburg State University in 1971 and his Ph.D. from Kansas State University in 1976. He concluded postgraduate studies at the University of Minnesota in 1987 and 1988.

Career:

Terry's career of nearly forty years was split in two major areas, teaching and consulting. His teaching started in the public school sector at Shickley Public Schools where he was from 1962-1965 and where he taught Biology for a year before becoming Principal for the remainder of the term.

He was a Teaching Assistant at Kearney State College from 1965-1966 while he completed his Master's Degree. Upon completion of his Ph.D., he taught and was the Department Chair at Northern State University from 1979 until 1994. Courses that he taught included Applied Physics, Computer Integrated Manufacturing (CIM), Statistics,

Engineering Materials, Metric Measurement, Plastics/Composites, Plastics Technology, and Total Quality Management (TQM). He was the Chairman of the Northern State University Faculty Senate in 1986.

Terry earned approximately \$700,000 in grants for research from 1989 to 1996.

Terry was an entrepreneur and consultant from 1986 until his retirement in 2007. He was President of Dakota Driving School in Aberdeen from 1986 until 2007.

He was a consultant for United Defense from 1990 until 2001, principally in the area of total quality management. His clients in the area of instrumentation and calibration included 3-M Aberdeen, Perfectseal Inc, Mankato, Horton Industries, Britton SD, and Safeguard Industries as well as expert witness testimony working the same area, among other clients.

Books Published:

Terry has published numerous articles and ten books during his career. The books include *Autobody: Repairing and Refinishing* (2000), *Total Quality Management* (1997), *Industrial Plastics: Theory and Application* (1997), *Metric Vendor List* (1992), *The Freeman List* (1991), *Secondary Plastics and Related Review* (1988), *Composites: A Design Guide* (1987), *Plastic* (1983), *Modern Industrial Plastics* (1979),

When Terry is not writing books he enjoys woodworking, auto-body, gun smithing, radio controlled air planes, and oil painting, just to name a few. He was the Chair of Absolutely! Aberdeen, Inc. from 2001 to 2005 and was Secretary of the Aberdeen Development Board from 1999 through 2005. He was a member of the Aberdeen Area Chamber of Commerce Industrial Development Board of Directors (Term 2001) and chaired the Aberdeen Planning Commission from 1990 until 1995.
