


Meeting of the First Continental Congress from an historic French engraving.

The painting above, George Washington and Lafayette at Valley Forge was painted by John Ward Dunsmore, and was published 1907. Dunsmore is known for his realistic paintings of the American Revolutionary era.

The largest collection of Dunsmore's art is at the Fraunces Tavern Museum. The Tavern, built in 1719, is best known as the site where Washington gave his farewell address to the officers of the Continental Army. It was originally built for the merchant Stephan Delancey as an elegant residence. Tavern-keeper Samuel Fraunces purchased the house in 1762 and coverted it into a most popular tavern. When the country's first capital was located in New York City the building was used to Departments of War, Treasury and Foreign Affairs.

In 1904, the Sons of the Revolution in the State of New York purchased the tavern and hired preservation architect William Mersereau to return the building to its colonial appearance. Fraunces Tavern® Museum opened to the public in 1907.



Continental Congress ratifies the Second Treaty of Paris

On January 14, 1784, the Continental Congress ratifies the Second Treaty of Paris, ending the American Revolutionary War.

This Treaty was known as the Second Treaty of Paris because the Treaty of Paris was the Treaty that had ended the Seven Years' War in 1763.

The treaty settled the boundaries between the United States and what remained of British North America. U.S. fishermen won the right to fish in the Grand Banks off the Newfoundland coast and in the Gulf of Saint Lawrence. Both sides agreed to release all prisoners of war. The United States promised to return land confiscated during the war to its British owners, to stop any further confiscation of British property and to honor the property left by the British army on U.S. shores, including Negroes or slaves. Both countries assumed perpetual rights to access the Mississippi River.


Despite the agreement, many of these issues remained points of contention between the two nations in the post-war years. The British did not abandon their western forts as promised and attempts by British merchants to collect outstanding debts from Americans were unsuccessful as American merchants were unable to collect from their customers, many of whom were struggling farmers.

Allen Greene, Speaker Extraordinaire, gives This Day in History. January 14 of each year is acknowledged as Ratification Day in the United States.

This day is in commemoration of the ratification of the Treaty of Paris on January 14, 1784 at the Maryland State House in Annapolis, Maryland by the Confederation Congress. This act officially ended the American Revolution and established the United States as a sovereign entity.

The painting entitled "Unfinished Treaty of Paris" by Benjamin West was not finished because the British negotiators refused to sit for the painting. Self-portrait by West is shown below.







The Battle of Pensacola began on this Day in History, March 9th, 1780. Bernardo de Galvez gathered a naval force of 40 ships and 3,500 men to capture the British occupied city of Pensacola. Galvez's flotilla survived a hurricane in harbor in New Orleans before sailing to Florida. The British suffered a complete loss with 105 dead and 1,113 capture. The Spaniards registered 78 dead and 198 captured.



Boston Massacre

On the cold, snowy night of March 5, 1770, a mob of angry colonists gathers at the Customs House in Boston and begins tossing snowballs and rocks at the lone British soldier guarding the building. The protesters opposed the occupation of their city by British troops, who were sent to Boston in 1768 to enforce unpopular taxation measures passed by a British parliament without direct American representation.

When the customs-house sentinel called for assistance, a British corporal and seven soldiers came to his aid. British Captain Thomas Preston assumed command of the riled Redcoats and ordered them to fix their bayonets. As the crowd dared the snow-pelted soldiers to fire, Private Hugh Montgomery slipped and fell, leading him to discharge his rifle into the jeering crowd. The other soldiers began firing a moment later, and when the smoke cleared, five colonists were dead or dying. Three more were injured. Crispus Attucks, a sailor of African and Indian ancestry, was the first to fall, as is commonly believed, the deaths of the five men are sometimes regarded as the first fatalities of the American Revolution.

The British soldiers were put on trial, and John Adams and Josiah Quincy Jr. agreed to defend the soldiers, in a show of support of the colonial justice system. When the trial ended in December 1770, only two of the six British soldiers were found guilty of manslaughter. They were branded on the thumb and Preleased.

The Death of General Warren at the Battle of Bunker's Hill (painted 1786) by John Trumbull (1756 – 1843). Trumbull was a soldier of the Revolution and sketched the British works at the Battle of Bunker Hill, which he witnessed. He was a personal aide to Washington and deputy adjuntant-general to Gates. Trumbull resigned from the army in 1777.

The paiting hangs in the Boston musuem of Fine Art and depicts a charge by the British up Breeds Hill. The two details show the death of two leaders of the battle. Colonial leader General Dr. Joseph Warren is shown dying after being hit by a musket ball. In the lower insert, Major John Pitcairn, falling back dying in the arms of Lieutenant Pitcairn's, his son.



Our History lessons. This day in History, April 8, 1780 The Siege of Charleston

The worst American defeat during the Revolution occurs when Charleston surrenders on 12 May. The British capture in excess of 3,000 Patriots and themselves lose about 250 killed and wounded. Carelessness causes a massive explosion of 180 barrels of captured powder and somewhat mars the victory. Neither Clinton nor the American commander, General Benjamin Lincoln, displays any inspiring leadership. When Clinton learns of an impending French expedition, he determines that he should be in New York, and General Charles Cornwallis assumes command of British forces in the South.

This Day in History The Siege of Charleston March 29 to April 29, 1780




The Timeline

On March 29, under the cover of fog, the British crossed the Ashley River upstream from the heavily fortified Ashley Ferry and established themselves on Charleston Neck. When the Americans learned that the British were on the Neck, they abandoned their breastworks at Ashley Ferry.

On April 1, the British had moved down into position to begin their siege works. While the British slowly closed in, naval maneuvering in Charleston Harbor for the Americans was a disaster. In December 1779, 4 frigates had arrived under the command of Commodore Abraham Whipple and were joined by 4 ships from South Carolina and 2 French ships. There were 260 guns afloat and 40 guns at Fort Moultrie. However, even before the British arrived, Whipple informed Maj. Gen. Benjamin Lincoln that the flotilla could not defend the entrance to Charleston Harbor. Lincoln questioned Commodore Whipple's conclusion, but Whipple was backed up by a naval board. Whipple chose to first withdraw to the mouth of the Cooper River. Meanwhile the British began their approach on March 20. When Whipple saw the size of the British attack fleet, he scuttled the ships at the entrance of the river

On April 2, siege works were begun about 800 yards from the American fortifications. During the first few days of the siege, the British operations were under heavy artillery fire. On April 4, they built redoubts near the Ashley and Cooper Rivers to protect their flanks.

This Day in History The Siege of Charleston March 29 to April 29, 1780



On April 12, Lt. General Henry Clinton ordered Tarleton and Ferguson to capture Monck's Corner, which was a crossroads just south of Biggins Bridge near the Santee River. Gen. Isaac Huger was stationed there 500 men under orders from Lincoln to hold the crossroads so that communications with Charleston would remain open.

On April 13, during the evening, Tarleton gave orders for a silent march. Later that night, they intercepted a messenger with a letter from Huger to Lincoln and thus learned how the rebels were deployed.

On April 14, at 3:00 A.M., the British reached the American post, catching them completely by surprise and quickly routing them. Following the skirmish, the British fanned out across the countryside and effectively cut off Charleston from outside support. South Carolina Governor John Rutledge left Charleston on April 13.


On April 21, a parlay was made between Lincoln and Clinton, with Lincoln offering to surrender with honor. That is, with colors flying and marching out fully armed, but Clinton was sure of his position and quickly refused the terms. A heavy artillery exchange followed.

On April 23, Cornwallis crossed the Cooper River and assumed command of the British forces blocking escape by land.

On April 24, the Americans ventured out to harass the siege works. The lone American casualty was Tom Moultrie, brother of Brig. Gen. William Moultrie.

On April 29, the British advanced on the left end of the canal that fronted the city's fortifications with the purpose of destorying the dam and draining the canal.


The Americans knew the importance of that canal to the city's defenses and responded with steady and fierce artillery and small arms fire. By the following night, the British had succeeded in draining some water. By May 4, several casualties had been sustained and the fire had been so heavy that work was often suspended. On May 5, the Americans made a countermove from their side, but by May 6, almost all of the water had drained out of the heavily damaged dam and plans for an assault began. On that same day, Fort Moultrie had surrendered.



Robert Morris was one of the signers of the *Declaration of Independence* and afterward the great financier whose credit saved Washington's Army in the darkest hours of the Revolution. The Surrender of General Burgoyne At Saratoga by by John Trumbull (1756 – 1843) is an oil on canvas measuring 12' x 18'. It was finished in 1821 and placed 1826 in the Rotunda of the U.S. Capitol. Depicted in this painting is the surrender of British General John Burgoyne to American General Horatio Gates at Saratoga, New York on October 17, 1777.

The British surrender occurs after two previous battles lost by the British while they awaited reinforcements that never arrived. This turning point in the American Revolution brought the French into the war and prevented the British from carving off the New England.





The Beginning of Our Independence

Connecticut was a colony of Great Britain (England) in the 1700s. A colony is a group of people who leave their homeland to settle in a new place. England made our laws and collected taxes from Americans.

Not all the colonists were happy with England making all the rules for America. The Americans who believed that we should be a separate country were called Patriots or Rebels. The Americans who wanted to stay part of Great Britain were called Tories or Loyalists.




Supplies, such as this powder keg, were stored in the supply depot.

Danbury, the Supply Depot

A supply depot was located in Danbury for the Patriots in the Continental Army. Danbury was on a river, had flat roads, and was protected by small hills. It was away from the ocean, where the British soldiers landed their ships. There was a military hospital on Park Avenue. Thousands of soldiers passed through the town. These things made Danbury a good, safe place to store military supplies.

Danbury's Burning!

General William Tryon led the British Raid

April 25, 1777: British General Tryon led 2,000 troops on a march to Danbury. They marched from the shores of Compo Beach in Norwalk (now Westport). Their mission was to raid the military supply depot in Danbury. They wanted to take medicine, tents, shoes, and bedding supplies.

When they got to Danbury, they started searching for the supplies. They took the supplies they couldn't carry out into the middle of the street and set fire to them. The British burned homes, the New Danbury Church, and more than 20 other buildings. British troops tried not to burn Tory houses, because Tories were loyal to Britain. The Tory houses were marked with a red cloth.



British soldiers were sometimes called "Redcoats" because of their red uniforms. They burned much of Danbury to prevent the townspeople from helping the patriots.



General David Wooster led the Patriot militia against. the departing British.

As night came, it began to rain. The rain could not put out the huge flames. Falling sparks started fires in other buildings. Smoke came from houses while ashes filled the streets with mud. The rain stopped the colonists from attacking. They could not fire their guns in the rain. So Danbury continued to burn and the British traveled on towards Ridgefield.

News of the burning of Danbury traveled quickly. Sybil Ludington, a young girl, helped to spread the news in neighboring New York



The Patriot militia helped to force the British to leave Danbury.

towns. Neighbors banded together to force the Redcoats to leave the area. General Wooster led the militia and forced the British back to their ships at Compo Beach.

After the raid, many Tories became Patriots. Citizens saw no reason for the British to burn homes and farmlands. They hated leaving their homes in search of safety only to come back and see their homes burned.

Loud knocking startled the Ludingtons as they sat down to dinner. "What could that be?" thought Henry Ludington. He was a general in the Continental Army. He had just returned from battle for a two-day leave. When he opened the door, he saw a very tired messenger.

"Hurry," the man said. "The British are burning Danbury."

General Ludington knew the troops would have to be gathered quickly. Danbury was only twelve miles away. What if they came closer? How would he get word to the troops? The messenger was far too tired to ride any longer.

Sybil looked at her father. She could tell what he was thinking. "I can do it!" she said. "I can ride and tell the militia to come."


Sybil's mother looked worried, but her father said, "You ride well Sybil, do you think you can do this?"

"Don't worry." Sybil said. "I know the land well. I'll be careful and I'll hurry."

General Ludington walked Sybil to the barn and helped her saddle Star, her horse. He said, "You need to be very careful. It'll be dark soon. Loyalist spies may be hiding in the woods."

"I'll be careful, and I'll hurry." Then she mounted her horse and galloped off.

Sybil rode over forty miles that night. She rode in the rain and on dark, wooded roads. She stopped at houses and towns all along the way. She shouted, "Gather at the Ludington's. The British are burning Danbury!" She said it over so many times her voice began to hurt. When she finally arrived home the next morning, soldiers were already gathering. They were ready to fight the British. Sybil was proud of herself. She had helped the Patriots.

The fighting never came back to Danbury, but it changed the economy of the town. Fewer people farmed the land. Many craftsmen created their goods and used Danbury as a base for their trade. They made many items for the war. By 1780, Zadoc Benedict was making 3 hats a day!

A Spy!

Enoch Crosby lived in Danbury. He joined the Continental army and was sent to fight battles in the north. When his service in the army was over he went home to Danbury. He decided to enlist again and on

his way he ran into some Tories. Thinking he was a Tory, they told him where all their secret meetings were held. Crosby reported this to the Continental army who captured the Tories.

Crosby asked to be a spy in the Continental army. He was good at spying and was able to lead the Continental Army to capture many loyalists. He sometimes used the home of General Ludington as a hiding place.

A famous author, James Fennimore Cooper, wrote a book called *The Spy* which was thought to be based on Enoch Crosby.

... And a Traitor

Ever heard the phrase, "like a Benedict Arnold"?
Benedict Arnold was a leader in the Continental army.
He had fought in many battles. George Washington trusted him. He fought with General Wooster in the Battle of Ridgefield.

Arnold continued to fight for the Continental army. He was smart, ambitious and wanted success. He was successful, but it took a long time for him to be promoted to General.

Later, after Tryon's Raid, Arnold became a spy for the British. No one is really sure why he became a traitor. He may have

been unhappy that he wasn't made General faster. He may have wanted money. But, no matter the reason, he changed sides. To this day, someone who changes sides is called a "Benedict Arnold."



Food Anyone?

A soldier's food was not very good. Not only did soldiers cook their food over an open campfire, but they had to find the food too. Each day a soldier was given a daily ration: a pound of salt pork, dried peas, cornmeal or flour, and maybe vinegar or molasses for seasoning. Sometimes they would steal corn

from a farmer's field. Some women followed the troops taking care of chores like cooking, laundry, and sewing.

A Sense of History

One of the effects of Tryon's Raid and the burning of Danbury was the loss of original buildings. All the early historical records were burned in the fire too.

Our understanding of Danbury's early history comes from the memories of people who lived then. These memories were collected and written down.

William Pratt (1609–1678) was an early colonial settler, a lieutenant in the Pequot War, and a representative to the General Court of Connecticut for 23 terms. [12][13] William and his older brother John were two sons of Reverend William Pratt of England. William and John came to Massachusetts on the same ship as John Cotton and Thomas Hooker. Before that, William and John Pratt went with Thomas Hooker to Holland. Rev. Hooker and Rev Cotton attended the same college at Cambridge as Rev. William Pratt. All were strong believers in the Puritan movement. Rev. Hooker was an ardent believer in universal Christian suffrage and along with William and John Pratt broke away from Rev. Cotton of Massachusetts Bay Colony. They went on to found the Connecticut Colony, which on 14 January 1639 ratified "Fundamental Orders of Connecticut" which were inspired by the beliefs of Hooker. Connecticut is known as "The Constitution State" because of the hugely forward thinking of its founders, including the Pratt Brothers and Rev. Hooker who saw the future in American Democracy and freedom of Religion, as first espoused by its first truly Puritan Church leaders.

Facing little, if any, opposition from Patriot forces, the British went on a rampage, setting fire to homes, farmhouse, storehouses and more than 1,500 tents.

The British destruction continued for nearly a week before word of it reached Continental Army leaders, including General Benedict Arnold, who was stationed in nearby New Haven.




Francis Hopkinson may be the most accomplished of the signers of the Declaration of Independence from New Jersey. Born in Philadelphia, Pennsylvania on September 21, 1737, Hopkinson became an author and poet; a song-writer and musician; a lawyer and judge; an artist and Congressman. As an ardent Patriot, he played a role in the founding of the United States politically and culturally - he is credited with having a hand in the design of the first American flag and the designs of the seal of the State of New Jersey and the Great Seal of the United States.






On December 26, 1779, Clinton left New York with 14 warships and 90 transports for another attempt on Charleston. These contained an expeditionary force of around 8,500 men. They landed on Simmons Island on February 11. Advancing on the Charleston defenses, the British began constructing siege lines. http://militaryhistory.about.com/od/americanrevolution/p/American-Revolution-Siege-Of-Charleston.htmes on April 2.



On May 8, Clinton demanded that the Americans unconditionally surrender. Refusing, Lincoln again attempted to negotiate for an evacuation.

Again denying this request, Clinton began a heavy bombardment the following day. Continuing into the night, the British pounded the American lines. This, coupled with the use of hot shot a few days later, which set several buildings on fire, broke the spirit of the city's civic leaders who began pressing Lincoln to surrender. Seeing no other option, Lincoln contacted Clinton on May 11 and marched out of the city to surrender the following day.


British Fleet and troops attack undefended towns and destroy property and steal tobacco!

22 transports convoyed by the Royal Navy sailed from Sandy Hook with 1800 soldiers. The expedition landed May 10th at Portsmouth and took possession of the undefended town. The following day Detachments then moved on to capture Suffolk, Gosport and other small towns without opposition - except at Gosport where a garrison of 100 held out for awhile in Fort Nelson. Every nearby town was invaded as well as neighboring plantations. All were pillaged and burned. "the expedition destroyed or carried off 130 vessels and 130 hogsheads of tobacco valued at 2,000,000 Pounds Sterling, then sailed away without the loss of a single man."




A number of important events occurred in this area.

- The case law that has developed over time regarding First
 Amendment rights in the workplace has come from the public sector, as the government is directly affecting employees in public sector cases.
- There are no Washington cases that this author is aware of where freedom of speech has been protected under the First Amendment in private sector workplaces.








This Day in History

On September 11, 1777, American troops clashed with the British in the Battle of Brandywine in Pennsylvania, resulting in an American defeat that allowed the British to easily capture Philadelphia later that month.

In early September, with British general William Howe's troops advancing toward Philadelphia, George Washington deployed his army along the east side of Brandywine creek, about 25 miles from Philadelphia, and took up a defensive position to meet the British. Washington was expecting the British to launch a frontal attack, and at first, that's what appeared to be happening, as British troops congregated on the other side of the creek opposite Washington's center.

However, Washington received intelligence that a large force of the British army was heading north to cross the creek higher up and outflank the Americans. So Washington sent out orders to reposition his troops to meet the threat. But before the orders could be fully carried out, Washington received conflicting news that there were no British to the north, and he rescinded his orders. But it turned out that the original intelligence was correct, and there really was a large force of British about to outflank the Americans. Washington hastily

repositioned the right wing of his army to meet the British flanking maneuver, but the Americans couldn't withstand the British attack. Washington tried to reinforce his right with troops from the center, but it was too late. At about the same time, the British at the Americans' center also attacked and likewise overpowered the Americans there, and the American army was forced to retreat.

During the battle, the Americans suffered an estimated 1,300 casualties, with approximately 300 killed, while the British sustained 583 losses, with 89 killed. The Americans' loss enabled the British to take Philadelphia without a fight later that month, and the Continental Congress, which met in that city, was forced to move to Lancaster, Pennsylvania, for the time being. Despite their defeat, the American troops remained in relatively good spirits, seeing their loss as only a temporary setback. However, Washington's failure caused some Patriot leaders to question his skills as a commander.


Favorite Naval Quotes of Lt. Tom Green

"I have not yet begun to fight!" Captain John Paul Jones said this during the famous battle between *Bonhomme Richard* and *Serapis* on 23 September 1779. It seems that some of Jones' men cried for surrender, but not John Paul Jones. Captain Richard Pearson of *Serapis* asked Jones if he had surrendered. Jones uttered those immortal words.

"Damn the torpedoes, Full speed ahead!" Admiral David Glasgow Farragut. Aboard Hartford, Farragut entered Mobile Bay, Al. 08/1864, in two columns, with armored monitors leading and a fleet of wooden ships following. When the lead monitor Tecumseh was demolished by a mine, the wooden ship Brooklyn stopped, and the line drifted in confusion toward Fort Morgan. As disaster seemed imminent, Farragut gave the orders embodied by these famous words. He swung his own ship clear and headed across the mines, which failed to explode. The fleet followed and anchored above the forts.

fortune was due, in large part, to the values of this nation and the veterans who made the ultimate sacrifice for their country.



Birth of the U.S. Marine Corps

On November 10, 1775, the Second Continental Congress meeting in Philadelphia passed a resolution stating that "two Battalions of Marines be raised" for service as landing forces with the fleet. This resolution established the Continental Marines and marked the birth date of the United States Marine Corps.

Serving on land and at sea, the original U.S. Marines distinguished themselves in a number of important operations during the Revolutionary War. The first Marine landing on a hostile shore occurred when a force of Marines under Captain Samuel Nicholas captured New Province Island in the Bahamas from the British in March 1776. Nicholas was the first commissioned officer in the Continental Marines and is celebrated as the first Marine commandant. After American independence was achieved in 1783, the Continental Navy was demobilized and its Marines disbanded.

In the next decade, however, increasing conflict at sea with Revolutionary France led the U.S. Congress to establish formally the U.S. Navy in May 1798. Two months later, on July 11, President John Adams signed the bill establishing the U.S. Marine Corps as a permanent military force under the jurisdiction of the Department of Navy. Since then, Marines have participated in all the wars of the United States and in most cases were the first soldiers to fight. In all, Marines have executed more than 300 landings on foreign shores.

Today, there are more than 200,000 active-duty and reserve Marines, divided into three divisions stationed at Camp Lejeune, North Carolina; Camp Pendleton, California; and Okinawa, Japan. Each division has one or more expeditionary units, ready to launch major operations anywhere in the world on two weeks' notice. Marine expeditionary units are self-sufficient, with their own tanks, artillery, and air forces. The motto of the service is Semper Fidelis, meaning "Always Faithful" in Latin.

Retiring from law enforcement she began her thurd career as a college degreed Paralegal specializing in human resources and employment lawrising to the position of Human Resources/ Employee Relations Manager before retirement.


Colonel Mitchell graduted from Jack Yates High School here in Houston in 1969 prior to earning his BS iin Industrial Technology from Prairie View A&M College.

Colonel Mitchell is a well decorated Marine and while assigned to service in Japan he participated in "Operation Frequent Wind", which was the evacuation of Americans, foreign Nationals, and refugees from the Republic of Viet Nam. He was released from Active Duty November 1976 and immidiately joined the Marine Reserves. Over the ensuing 27 years he saw service in Southern Europe as part of NATO and also Operation Enduring Freedom/Iraqi Freedom among other stops along the way.

In civilian life he joined the American General Life Insurance Company as Manager Supply Department and remained for 25 years and retired from there in 2002.

This Day in History: November 9, 1764 Mary Campbell is released Parliament Enacts the Stamp Act: November 1, 1765



Tonight, This Day in History is in three parts. Part One:


The French and Indian war in America started in 1754 and ended in 1763. This was the North American theater of the worldwide Seven Years war involving the British, French and Spanish among others. The British were victorius and the French ceded landed east of the Mississippi to Great Britain as well as Canada. French land west of the Mississippi went to Spain. Indian tribes were not signatories and fighting continued. Most notable was Pontiac's Rebellion which occurred in Ohio.

Colonel Henry Bouquet was ultimately successful in defeating the Indian Confederation. A requirement of cessation of holtilities was that British captives be returned. Over 200 captives were returned including a 17 year old girl, Mary Campbell who was released on November 9, 1764. She was captured at the age of 12 by the Leanape Indians also known as the Delaware Indians. Peace with the Indians was signed in 1765.

The plaque above commemorates her release.

This Day in History, Part Deaux

In 1764, the Sugar Act was enacted, putting a high duty on refined sugar. Although resented, the Sugar Act tax was hidden in the cost of import duties, and most colonists accepted it. One purpose of this tax was to pay for the French and Indian War.

Passed without debate by Parliament in March 1765, the Stamp Act was designed to force colonists to use special stamped paper in the printing of newspapers, pamphlets, almanacs, and playing cards, and to have a stamp embossed on all commercial and legal papers.


The Stamp Act, however, was a direct tax on the colonists and was a major cause of the Revolution: taxation without representation.

The Stamp Act was enacted on November 1, 1765.



The stamp itself displayed an image of a Tudor rose framed by the word "America" and the French phrase Honi soit qui mal y pense—"Shame to him who thinks evil of it."

THE REPEAL, OR THE FUNERAL OF MISS AME-STAMP

One of the most famous and popular of the political satires commenting on the Stamp Act is this one, which actually celebrates the demise of the tax. A funeral procession composed of supporters of the act carry a small coffin containing the remains of the bill toward an open vault, appropriately adorned with two skulls. It has been prepared for the internment of all unjust acts that would alienate Englishmen. Leading the cortege and preparing to deliver the funeral eulogy is the Reverend W. Scott, who is followed by the mourners: Grenville, carrying the coffin, Bute, Bedford, and Temple, the same government officials whom jubilantly celebrated the passage of the act.


On the dock, are depicted the large unshipped cargoes destined for America that accumulated during the period when the act was in force. Ships labeled "Conway," "Rockingham," and "Grafton" that represent Whig leaders responsible for the repeal of the bill now stand rea dy to carry the goods to their destinations. Stamps just returned from America are also stacked on the wharf. One crate contains the statue of William Pitt, another English leader responsible for the repeal. It is probably the one intended for Charleston, South

The Georgian Papers Program

The SAR has entered into an exciting new partnership with King's College London (KCL), one of the world's leading academic institutions. This partnership presents the SAR with a unique opportunity to play a leading role in a major international academic project that has the potential to impact our understanding of the 18th century and the American Revolution. More importantly, we will support two of the SAR's three historical goals: "preserve records relating to the events leading up to and during the American Revolution"; and "support research and presentations . . . related to the history and people of the period 1750-1800."

In 2014 KCL entered into an agreement with the Royal Archives to digitize and interpret the personal papers of King George III. These documents – more than 250,000 of them – have been in storage since George III's death in 1820. They have had only scant academic attention over the past 200 years, and there has been no systematic attempt to catalogue them or make their contents available to scholars or the public. Until now. This collection is likely the last unstudied original-source material relating to the American Revolution!

KCL is establishing a network of relationships on both sides of the Atlantic to carry out a comprehensive fiveyear program of academic study of the papers and outreach activities in the United Kingdom and abroad. As a partner in the Georgian Papers Program, the SAR will sponsor leading scholars from the U.S. as Visiting Professors at KCL for eight weeks each year. These SAR Visiting Professors will have regular, direct access to the Royal Archives at Windsor Castle, lead academic seminars on the interpretation of the papers, interact with the faculty and students, and guide and mentor students with interests in relevant fields. KCL's other U.S. partners include the Omohundro Institute of Early American History & Culture at the College of William & Mary, the Mount Vernon Ladies Association, and the Fred W. Smith National Library for the Study of George Washington.



Judge Butler presents SAR Medal to King Felipe

Summary: The Spanish King during the American Revolutionary War, Carlos III, was the much older uncle of King Louis of France. In 1761, Spain and France entered into a "Borbon Family Compact", which was a mutual defense treaty. By the 1763 "Treaty of Paris" settling the French and Indian War, Spain was granted all land west of the Mississippi River. Spain and England had been at war about 2/3 of the time for several hundred years. Spanish treasure ships from Mexico and South America to Spain were being attacked and captured by British pirates and privateers.

When Carlos III appointed Bernardo de Galvez as Governor of Louisiana in 1776, he told Galvez to prepare for war with England. Galvez immediately began to recruit a "militia". Cash, arms, ammunition and supplies from Spain began arriving at New Orleans and Philadelphia in 1776, and continued throughout the war.

Spain and France each donated 1,000,000 Livres to the American cause.

By the time Spain declared war on England in June, 1779, Galvez had an army of over 1,400, including Spanish soldiers, Canary Islanders, Acadians ("Cajuns"), free Negros, Germans and Indians. The book covers the battles in which Galvez and his troop seized British forts at Manchac and Baton Rouge, LA; Natchez, MS; Mobile, AL; and Pensacola, FL. Galvez showed an uncanny talent as a commander. Galvez' actions in North America removed the threat of a second British front from either the west or south, and kept the Mississippi - Ohio River Rivers open for supplying George Washington at Ft. Pitt, and Gen. George Rogers Clark at Ft. Nelson in current day Louisville. Spain and England were involved in a world war. Spanish army and navy units battled the English in the Mediterranean, Central America, India, South Africa, and the Philippines. The world wide battles prevented hundreds of war ships and tens of thousands of British troops from being available to send to the colonies. About 17,000 Spanish soldiers fought the English in North America during the war.

Galvez and his army captured several thousand British prisoners (2,500 in one day) and hundreds of English ships - 55 in one day - together with large quantities of cannon, cannon balls, rifles, ammunition and military supplies.

Impact: Now, Hispanic children in the US, instead of feeling disengaged with the nation, can feel like they are a part of our country, knowing that many of their ancestors played a vital role in this nation gaining its freedom from England.

SAR/FAMILYSEARCH PROJECT PROPOSAL AND SCOPE

FamilySearch and SAR will each be independent contractors and nothing about the project will make either Party the employee, agent or representative of the other Party, nor will the Parties be considered as joint venturers or partners for any purpose. The below project description is conceptual. The parties anticipate entering into a written agreement, which has not yet been created or negotiated.

1. CONTENT PREPARATION

- a. <u>Scope of Original Records</u>. The Parties intend that the collection of SAR Membership Applications with their associated supporting documentation from earliest to present be digitally photographed, electronically indexed and made available to the public for personal family history research.
- b. <u>Document Preparation</u>. SAR will be responsible for going through all of the documents in each applicant's bundle, marking with a red dot all documents it deems should not be made publically accessible. SAR will pull all documents marked with a red dot and locate them at the beginning of each bundle. FamilySearch will not digitally photograph red dot documents. FamilySearch will seek for 2 full-time volunteers to help with documentation preparation. SAR will seek and enlist all other volunteers.

2. CONTENT DIGITIZATION

- a. <u>Creating Digital Images</u>. FamilySearch will create digital images of the Records on site at SAR's facility based on FamilySearch's standard specifications (available upon request) without charge.
- b. <u>Copy to Record Custodian</u>. When needed, SAR may request a single digital copy of the Digital Images for its internal use (as defined below), which FamilySearch agrees to provide in FamilySearch's then-standard format without charge. If any such copy is lost or destroyed, SAR may request another copy, at SAR's expense.
- c. <u>Creating Research Materials and an Index</u>. FamilySearch will create an electronic index of the Digital Images consisting of FamilySearch's standard fields, as well as four additional fields requested by SAR (National Number, ACN if present, Patriot (qualifying ancestor) and Type of Service). The FamilySearch-produced index will be exclusively owned by FamilySearch. When needed, SAR may request a single electronic copy of the Digital Images for its internal use (as defined below), which FamilySearch agrees to provide in FamilySearch's then-standard format without charge. If any such copy is lost or destroyed, SAR may request another copy, at SAR's expense.

3. RIGHTS; USE OF PREMISES; COMPLIANCE WITH LAWS

- a. <u>Rights to Use Records, Digital Images and Indexes; Use Limitations</u>. SAR retains all rights to the Records it heretofore has held, except as expressly provided herein:
 - FamilySearch may create Digital Images of the Records and may use or transfer the Digital Images for any purpose
 without limitation. FamilySearch may license, reproduce, display, distribute, transmit, create derivative works of, and
 otherwise use the Digital Images as FamilySearch sees fit, and may do so in any and all media formats now known or
 hereafter invented, including without limitation internet hosting for public access.
 - 2. Details on handling applications containing potentially sensitive or private information, i.e. generational details of living individuals, minors, phone numbers, social security numbers, etc. have not yet been fully sorted out by FamilySearch and SAR. One thought is for SAR to inform its membership and ask them to indicate in writing if they do not want their applications made public. Another thought is to exclude junior member applications, and possibly applications after 1998, which could include details about minors.
 - 3. FamilySearch will own all rights to the Digital Images and indexes created hereunder, and each Party hereby grants to the other Party the non-exclusive, perpetual, worldwide, irrevocable, fully-paid, and royalty-free permission to perform the tasks and use the Digital Images, subject only to the restrictions set forth herein.
 - 4. SAR agrees (a) not to distribute or license copies of Digital Images or Indexes for any form of third-party commercial use, and (b) not to permit copying or distribution of all or substantially all of the Digital Images or Indexes by or to any third-

- party, without first obtaining written authorization from FamilySearch.
- 5. Neither Party may display or otherwise use the other Party's (or any of its affiliated entities') name or trademarks, and the Parties will refrain from such use without written permission from the other Party.
- 6. FamilySearch will display some form of attribution, viewable by its patrons who access digital images of SAR's records on FamilySearch's website. The attribution will indicate in some fashion that patrons interested in additional information, such as purchasing record copies, may contact SAR directly, and provide a link to SAR's website or other contact information.
- b. <u>Record Custodian's Premises and Security</u>. SAR will provide FamilySearch with timely, reasonable access to the Records at no cost to FamilySearch, including sufficient space near the Records in a secure location (where there will be no third-party access to the Records and/or the digital imaging equipment) acceptable to both Parties for installation and operation of digital imaging equipment (*i.e.*, electricity, Internet connectivity, environmental considerations, etc.), until digital imaging is completed.

4. GENERAL TERMS

- a. <u>Term and Termination</u>. Once an agreement is signed, either Party may terminate by providing 90 calendar days Notice (as defined below) to the other Party. Any termination of the Agreement will only affect the right to create additional Digital Images after the termination date, and will not terminate or otherwise limit the use rights granted prior to the date of termination.
- b. <u>Indemnification and Covenant Not to Sue</u>. Each Party will indemnify, defend, and hold harmless the other Party, and all affiliated entities, officers, directors, representatives, and employees thereof, for and against all costs, losses, damages, and attorneys' fees attributable to any third-party claim brought against the other Party arising from a breach or alleged breach of the Agreement by the indemnifying Party. Except in cases of willful misconduct or gross negligence, in recognition of the nature of the Parties as non-profit entities and to the extent permitted under applicable law, each Party will waive its right to bring any legal claim against the other Party for any loss or damage in connection with the agreement.
- c. <u>Timeline</u>. A timeline has not yet been determined for any aspects of this project.

Below are concerns/requirements SAR recently asked FamilySearch to address. FamilySearch's comments are in BOLD.

The following is a list of concerns to consider for a contractual agreement on the Application and supporting Documentation project.

The application images for third party digitization and utilization:

- 1. The member's contact information is to be redacted, so as to not appear on the internet or other digital means. See #4 comments below.
- The section listing names and birth information of the children of the member is to be redacted, so as to not appear on the internet or other digital means.
 See #4 comments below.
- 3. On the application format in the lineage section, the information shown in generations 1 & 2 is to be redacted, so as to not appear on the internet or other digital means. This may need to be extended to generation 3 also depending upon the information shown and if generation 3 is living or deceased. (Family Search may have a suggestion regarding the methods they use to determine the release of information.)
 See #4 comments below.
- 4. A member wishing to request the removal of his application from the internet listing of Family Search must contact the National Headquarters in writing. The National Headquarters will then consider the request and forward it to Family

产

Search for action. This will create the "opt out" option, but the authority still lies with the National Society the owner of the application.

The redaction suggested in items 1-3 above would be difficult, time-consuming and costly, and would greatly erode the value of the applications for family history researchers. FamilySearch suggests only item 4 be utilized, i.e. application packets will be de-published at SAR's request.

- A notice with the option to order a Record Copy must be included with the display of any SAR application directing the viewer to the National Society's Record Copy page.
 FamilySearch could provide an attribution statement, directing people to SAR for additional information.
- 6. This agreement cannot restrict or interfere with any other third party projects, such as a membership directory, data system development, museum gallery display development, mobile app development, etc. of the National Society. SAR would be permitted to use the index and images for its purposes, but not sell or give them ALL or SUBSTANTIALLY ALL to a 3rd party who might use them for commercial purposes.
- 7. The applications will not physically leave the National Headquarters. A working space for the digitization process will need to be set aside for use by Family Search or their sub-contractor.

 FamilySearch would perform digitization at SAR's facility.
- 8. Any application which features a field signifying a Social Security Number is to be redacted from any and all digital images.
 Social Security Numbers would need to be an index field. FamilySearch could consider either redacting SSNs from images before publishing, or not publishing images containing SSNs. With the SSDI already publically accessible, FamilySearch questions the need to redact SSNs of dead people. Since Ancestry has had SAR applications to 1971 online for over 5 years without much problem, FamilySearch suggests no redaction of these applications.

The documentation images for third party digitization and utilization:

- Any vital statistic document older than 72 years of the date published on the vital statistic form can be made available
 on the internet or other digital means. If the vital statistic document is not older than 72 years a digital image can be
 made and not released until the 72 year threshold is met.
 Any supporting document that should not be publically viewable should be marked under SAR's direction during the
 document preparation phase, and FamilySearch would then not photograph it.
- 2. Any Daughters of the American Revolution (DAR) application documents that may be used as a supporting document within the SAR document files can be digitized for SAR internal use only. The same DAR documents cannot be made available through the internet or other digital means. The SAR does not own the rights to these documents nor does the SAR have the authority to make them available to the general public or a third party. Any supporting document that should not be publically viewable should be marked under SAR's direction during the document preparation phase, and FamilySearch would then not photograph it.
- 3. Any Children of the American Revolution (C.A.R.) application documents that may be used as a supporting document within the SAR document files can be digitized for SAR internal use only. The same C.A.R. documents cannot be made available through the internet or other digital means. The SAR does not own the rights to these documents nor does the SAR have the authority to make them available to the general public or a third party. Any supporting document that should not be publically viewable should be marked under SAR's direction during the document preparation phase, and FamilySearch would then not photograph it.
- 4. Any documentation that appears to be an application document from another lineage society (such as, The General Society of Mayflower Descendants, General Society of Colonial Wars, General Society War of 1812, etc.) that may have

been accepted as documentation at one time can be digitized for SAR internal use only. The same lineage society documents cannot be made available through the internet or other digital means. The SAR does not own the rights to these documents nor does the SAR have the authority to make them available to the general public or a third party. Any supporting document that should not be publically viewable should be marked under SAR's direction during the document preparation phase, and FamilySearch would then not photograph it.

5. Any document which features a field signifying a Social Security Number is to be redacted from any and all digital images.
SSNs on applications would be indexed so FamilySearch knows which applications contain SSNs. Supporting documents containing SSNs would need to be marked under SAR's direction during the document preparation phase, and FamilySearch would then not photograph these documents.

Other concerns to consider:

í

- 1. Damage to documents. Depending upon the equipment utilized during the process there is the potential of a missed staple with the documents being fed into a sheet feed process that may damage the document.

 FamilySearch does not anticipate using any type of sheet-fed scanning.
- Misplacement of returned document bundles. Bundles placed in an improper order when placed back on the shelf will
 create future issues when the staff will go looking for the document bundle.
 FamilySearch could photograph documents in packets in the order they are presented to FamilySearch's camera
 team, and left by FamilySearch in that same order.




MOTIONS SAR 2016 CONGRESS

 - ★ Central District SAR or Central SAR District
 - ★ George Washington SAR Chapter

- MOTION #4: Logo and identity protocols should be put into use immediately. Nothing currently in use should be discarded simply use the new logo when reordering letterhead, business cards, etc.
 - *Begin using the new logo on the SAR Website, Facebook, advertising, press releases, and letterhead, anything that becomes visible to the public. Full implementation of the SAR brand is recommended to be accomplished within two years.

 - Winner of the SAR American History Teacher Award receives the Dr. Tom and Betty Lawrence American History Teacher Award.





Brief History of the Kansas Society

(adapted from NSSAR History, Vol. III, 1983-2000)

Kansas was admitted to the Union in 1861. Thirty-one years later, a handful of these pioneers were chartered as the Kansas Society, Sons of the American Revolution. The Kansas Society's organizational meeting took place on March 31, 1892, in Topeka, KS, with Avery Washburn elected as its first President. Judge Franklin G. Adams, as secretary for many years, was the motivating force for the new organization. In 1892 the Kansas Society sent Judge Adams, Edward Wilder and Henry J. Adams to New York City as delegates to the third National Congress.

Arthur M. King was the lone Compatriot of the Kansas Society to serve as President General (1980). Thirteen members of KSSSAR are on record as having served as Vice President General of the South Central District: Robert Stone (1929), Ambrose Deatrick (1936), William F. Turrentine, Jr. (1957), Donald C. Little (1967), Scott E. Kelsey (1969), C. Y. Thomas, II (1975), Arthur M. King (1977), Augustus di Zerega, V (1982), Robert O. Dickey (1984), Dr. Philip W. Bernstorf (1990), Thomas E. Smith, Jr. (1993), Herrick H. Kesler (1997), Edgar E. Grover (2002), and Barnett Ellis (2007), and Peter Grassl (2012).

KSSSAR Chapters include: Washington (Wichita, founded 1897), Thomas Jefferson (Topeka, 1924), Delaware Crossing (Johnson County, 1960), Bennington (Salina, 1982), Sons of the Plains (Hutchinson, 1984), Charles Robinson (Lawrence, 1985), Fort Hays (Hays, 1985), Fort Scott (Ft. Scott, 1985), Konza Prairie (Manhattan, 1997), Monticello (NW Johnson County, 2006), Henry Leavenworth (Leavenworth County, 2009), and Henry Seward (Liberal, 2011).
