Americans have been meeting since 1774, and even before, in the cause or commemoration of Freedom. And, Patriots are still meeting today.





The painting above, George Washington and Lafayette at Valley Forge was painted by John Ward Dunsmore, and was published 1907. Dunsmore is known for his realistic paintings of the American Revolutionary era.

The largest collection of Dunsmore's art is at the Fraunces Tavern Museum. The Tavern, built in 1719, is best known as the site where Washington gave his farewell address to the officers of the Continental Army. It was originally built for the merchant Stephan Delancey as an elegant residence. Tavern-keeper Samuel Fraunces purchased the house in 1762 and coverted it into a most popular tavern. When the country's first capital was located in New York City the building was used to Departments of War, Treasury and Foreign Affairs.

In 1904, the Sons of the Revolution in the State of New York purchased the tayern and hired preservation architect William Mersereau to return the building to its colonial appearance. Fraunces Tayern® Museum opened to the public in 1907.

#### Thomas Paine The American Crisis, December 23, 1776 (by Orson Welles )

THESE are the times that try men's souls. The summer soldier and the sunshine patriot will, in this crisis, shrink from the service of their country; but he that stands by it now, deserves the love and thanks of man and woman.

Tyranny, like hell, is not easily conquered; yet we have this consolation with us, that the harder the conflict, the more glorious the triumph. What we obtain too cheap, we esteem too lightly: it is dearness only that gives every thing its value. Heaven knows how to put a proper price upon its goods; and it would be strange indeed if so celestial an article as FREEDOM should not be highly rated.



The presentation is entitled "The Lion Sleeps Tonight" and is on the First Battle of Trenton. For fun, Tom added riffs of the music by The Tokens but the home run is the stentorian voice of Orson Wells as he reads "American Crisis" by Thomas Paine.

Did you know that Paine was the equivalent of an embedded reporter? He wrote this in early December, published December 19th, and read to the troops on December 23rd, 1776. The crossing of the Delaware started just before midnight on Christmas Day; Washington and his troops arrived at 8:00 the next morning being harassed by a driving snowstorm.

It was a complete victory over the Hessian troops!

# Main Speaker



The speaker for the evening is the Rankin Oration Contest winner, Noah Hagler. His oration is "Iron Will: The Story of Samuel Whittemore."

Whittemore was an American farmer and soldier, who at 78 years of age became the oldest known colonial combatant in the American Revolutionary War. As the British soldiers retreated from the Battles of Lexington and Concord, they shot the Whittemore in the face, bayoneted him at least six times, and clubbed him. But a doctor patched up Samuel Whittemore and the 78-year-old lived. For another 18 years!

Allen Greene has started a new feature talking about Flags over the United States. He picks the Bennington which features a large '76' in the canton and its stars have seven points each! One legend claims that the original Bennington flag was carried off the field by Nathaniel Fillmore and passed down through the Fillmore family, and was, at one time, in the possession of President Millard Fillmore, Nathaniel's grandson. This is largely discounted as the flag material dates to a much later time, but still it makes for a good tale!



Tom Jackson talks about "An Appeal to Heaven." This Flag was designed by George Washington for use on a squadron of six cruisers, acquired using the wealth of his wife Martha. The pine tree represents the fact that they were used for the masts of the great sailing ships of the time. The slogan "An Appeal to Heaven" is forceful and represents a call to action couched in the words of John Locke. Locke's "Second Treatise of Government,":...where the body of the people, ... is deprived of their right... and have no appeal on earth, then they have a liberty to appeal to heaven, whenever they judge the cause of sufficient moment.

#### "Bloody Massacre on King Street"

March 5, 2020, commemorates the 250th anniversary of the Boston Massacre. On that frigid, snowy evening in 1770, Private Hugh White was the only British soldier guarding the King's money stored inside the Custom House on King Street. Private White came under threat of attack from Boston citizens after having an altercation with Edward Garrick. Soon the town's church bells rang signaling for more local citizens to come and observe the commotion. Fearing for his life, White sent word to Captain Thomas Preston. Captain Preston soon arrived with six other armed men.

As the crowd continued to grow, Captain Preston ordered his men to load their muskets and then proceeded to tell the mob to disperse. Having not went home, the crowd continued to taunt the soldiers daring them to fire their weapons and throwing snowballs, ice, and oyster shells. Private Montgomery was then struck by an object from the crowd and fell to the ground. Once Montgomery recovered, he stood up and fired into the crowd without orders given to do so. One by one the other soldiers discharged their muskets. Among the five who ultimately died at the hand of Captain Preston's men, six more were wounded. The crowd soon dispersed, and an investigation ensued.

The Boston Massacre is one of several pivotal events leading to the Revolutionary War, and ultimately, the signing of the Declaration of Independence.

*The Death of General Warren at the Battle of Bunker's Hill* (painted 1786) by John Trumbull (1756 – 1843). Trumbull was a soldier of the Revolution and sketched the British works at the Battle of Bunker Hill, which he witnessed. He was a personal aide to Washington and deputy adjuntant-general to Gates. Trumbull resigned from the army in 1777.

The paiting hangs in the Boston musuem of Fine Art and depicts a charge by the British up Breeds Hill. The two details show the death of two leaders of the battle. Colonial leader General Dr. Joseph Warren is shown dying after being hit by a musket ball. In the lower insert, Major John Pitcairn, falling back dying in the arms of Lieutenant Pitcairn's, his son.

The Surrender of General Burgoyne At Saratoga by by John Trumbull (1756 – 1843) is an oil on canvas measuring 12' x 18'. It was finished in 1821 and placed 1826 in the Rotunda of the U.S. Capitol. Depicted in this painting is the surrender of British General John Burgoyne to American General Horatio Gates at Saratoga, New York on October 17, 1777.

The British surrender occurs after two previous battles lost by the British while they awaited reinforcements that never arrived. This turning point in the American Revolution brought the French into the war and prevented the British from carving off the New England.

1917 Compatriot Elmer Wentworth (PG 1916-1918) prevailed upon the Iowa State Legislature to provide for the observance of Constitution Day and also in public schools.

1917-1918 American's Creed, written by SAR Compatriot William Tyler Page, submitted in a contest, judged to be the best entry, presented to the Speaker of the House, read to Congress and then printed in Congressional Record #102, April 13, 1918.

In 1917, the Sons of the American Revolution formed a committee to promote Constitution Day. The committee, chaired by <u>future PG David Pierson</u> would include <u>Compatriots</u> such as Calvin <u>Coolidge</u>, John D. <u>Rockefeller</u>, William Howard Taft, Henry Cabot Lodge and General John Pershing.

In 1917 the Kentucky SAR Society held a Constitution Day celebration with 65,000 in attendance.

In 1922 SAR Societies reported over 60,000 Constitution Day Celebrations.

### REFERENCES

### Benjamin West (1738 -1820)

Born in Pennsylvania, he was the first American artist to study art in Italy in 1760. He went to London in 1763 and was appointed as a charter member of the Royal Academy of Arts in 1768. In 1772, King George III appointed him as his historical painter.

At West's studio in London, numerous American painters developed their skills. Among them were Charles Willson Peale, John Trumbull, Samuel F.B. Morse, and Thomas Sully. West left a great legacy of art, including the other artists he influenced.

### Charles Willson Peale (April 15, 1741 - February 22, 1827)

Born in Maryland, Peale was apprenticed as a saddle-maker. From 1767-1770, he studied under Benjamin West in London. Peale opened a studio in Philadelphia in 1770 and painted many notables. He fought at the Battle of Princeton.

Over the years, Washington sat for him for seven portraits. *Washington at Princeton* was perhaps the first publicly commissioned painting in America. Peale, a Renaissance man who had a wide range of interests, including the natural sciences, founded Peale's Museum.

Peale had sixteen children, many of them named after artists. He was widowed three times.

### Rembrandt Peale (February 22, 1778 - October 3,1860)

Born in Bucks County, Pennsylvania, on Washington's birthday, he was the son of Charles Willson Peale. At the age of seventeen, Rembrandt painted a portrait of George Washington. He later painted versions of Washington titled *Patriae Pater* (Patriot Father), one of which is on my website, jackbusiek.com. A famous painting of Thomas Jefferson (1800) is in the White House.

Rembrandt had nine children and was involved with the museum business for decades. He was an educator in later life and authored numerous articles on art.

### John Trumbull (1756 -1843)

Born in Connecticut, he witnessed the Battle of Bunker Hill. He was an aide to Washington in 1776. He painted three well-known "martyrs" works and the paintings in the Rotunda, including *Declaration of Independence* and *Surrender of General Burgoyne*, at Saratoga.

### William Ranney (May 9, 1813 - November 18, 1857)

Born in Connecticut, he became the best artist to serve in the Republic of Texas Army. He is best known for scenes of the Revolutionary War, for paintings of frontier and Western experiences, and wildlife. He was a very patriotic man who died too young.

- 1. intro and Welcome
  - a. Good evening and welcome to the Texas SAR Nominating Committee. Thirty-nine of our chapters are represented here tonight, which is probably double the largest representation that we've ever had before. I am Tom Jackson out of the Rankin chapter and I have been appointed by President Drake Peddie to chair this committee. David Temple from the Dallas chapter has been appointed by President Peddie as the Vice Chairman and Secretary. I have appointed Mel Oller of the Freedom chapter to be our Zoom host and our Sergeant-at-Arms. I also appoint PG Nathan White of the McKinney chapter to be our acting Parliamentarian. I appoint Allen Henshaw of the Paul Carrington chapter to be our election judge tonight. I was State President for 2018-2019 and David was President 2019-2020.
  - b. We meet tonight with the august objective of selecting a slate of officers to be presented to the delegates at the state convention on Saturday of this week. The delegates will select the officers by majority vote. This procedure is memorialized in our bylaws. If you speak tonight, please state your name and the chapter you represent.
  - c. The job of the Chairman of this committee is to assemble a slate of officers for your consideration. Tradition dictates that the Chair ask all incumbent officers if they wish to run for re-election and, if so, their name is placed in the officer slate for consideration by this committee. The only non-incumbent is District 3 Vice President Candidate Peter Baron of the San Antonio chapter. District Vice Presidents must have the support of the chapters they serve.
  - d. The COVID-19 pandemic forced a cancellation of the State Convention and the change of officers. Accordingly, this summer the Board of Managers met electronically and elected a slate of officers to serve until the State Convention could be held. That interim action will be ratified by the delegates at the State Convention. That action does not modify your obligation tonight.
  - e. You have been provided with the initial slate of officers for consideration and David Temple will read that list. After he has read the list, I will ask if there are any challenges and those challenges will be noted. I will then call for a motion to approve the slate of uncontested officer positions and ask for a second. We will the vote on the uncontested slate using the poll feature. If everyone is comfortable using the poll feature, then we will use that approach for any and all contested elections. Should anyone not feel comfortable with the poll feature, we will use the check mark feature in the chatroom. The poll feature permits the individual vote to be secret, while the chatroom permits everyone to see how everyone else voted. Thus, we do not recognize service such as military service, charitable service, religious service unless there is a component of service to the SAR.

# The National Society of the Sons of the American Revolution

INSTITUTED JULY 4, 1876

ORGANIZED APRIL 30, 1889

March 31, 2020

Dear National Trustee:

The leadership of the National Society of the Sons of the American Revolution knows that the last several weeks have been challenging. We continue to navigate the rapidly changing COVID-19 environment, especially as it pertains to our upcoming 130<sup>th</sup> Annual Congress in Richmond, Virginia.

However, this letter requests a ballot vote from the Board of Trustees on the following motion:

# That full authority be delegated to the Executive Committee to determine, at the appropriate time, and as it applies solely to the 2020 Annual Congress, whether it is desirable to hold a one day Congress, a two day Congress, a full Congress or no Congress, and that full power be reposed in the Executive Committee to make the final determination of the format, place, and the time.

Because we understand that the National Trustees may have questions regarding this motion, we have tried to provide some answers in this letter.

#### Why are we seeking approval of this motion?

Although the National Society remains focused on hosting our Annual Congress in Richmond from July 11-15, 2020—and continues to work with the Virginia Society congress planning committee—the COVID-19 pandemic has required contingency planning. As a result of this unprecedented pandemic, the National Society must be mindful of—and make decisions based on—the health and wellbeing of our Compatriots, local conditions on ground in Virginia, timelines and other deadlines imposed on the National Society by the Richmond Marriott hotel and the NSSAR Constitution and Bylaws, and any issues that may arise with the previously-selected Richmond-area venues. Social distancing guidelines, orders issued by local authorities (stay-at-home, shelter-in-place, or mandatory self-quarantine orders for travelers entering a state), and other travel restrictions may continue to change between now and the start of the Annual Congress. The existing requirements for noticing and holding a meeting of the Board of Trustees may not provide the necessary flexibility during the current emergency.

#### What authority supports the above Motion?

"In an emergency," Article V, § 1 of the Constitution of the National Society of the Sons of the American Revolution provides that "the time and location of an Annual Congress may be changed by the affirmative vote of two-thirds of the Board of Trustees voting upon the question by mail; provided that votes by mail shall be postmarked to the Executive Director within ten days after the solicitation of said votes; and provided further, that not less than twenty-six Trustees shall have voted." NSSAR Bylaw 16, § 7 corresponds to this by providing that the Board of Trustees may use a ballot to change the location of an Annual Congress.

NSSAR Bylaw 16, § 5 provides, in relevant part, that "[t]he Board of Trustees may authorize the Executive Committee to perform such duties of the Board it may deem necessary between meetings of the Board of Trustees." NSSAR Bylaw 18, § 2(b) also provides that the Executive Committee "shall perform such duties as may be committed to it by and Annual Congress of the Society, or by the Trustees."

#### Has the Board of Trustees ever delegated this type of authority to the Executive Committee?

Yes. While our experience with emergency situations fortunately has been limited, the National Society did cancel the 1945 Annual Congress (although the 1918 Congress did not contain a quorum and no business was conducted). In preparing this letter, research indicated that at the May 18, 1944 Board of Trustees meeting held in Harrisburg, Pennsylvania, the Board of Trustees approved a nearly-identical motion to that worded above, delegating to the Executive Committee the authority to determine whether a Congress would be advisable during the remaining years of World War II.

During its February 17, 1945 meeting in Washington, D.C., the Executive Committee, utilizing the authority previously provided by the Board of Trustees, unanimously approved the following resolution:

"RESOLVED, that because of travel conditions and the ruling of the Office of Defense Transportation, the National Society of the Sons of the American Revolution will not hold its Annual Congress in May, 1945."

President General Smith L. Multer wrote that "no Congress could have convened that would have met the requirements laid down by the Office of Defense Transportation. There is no provision in the Constitution of our National Society that would permit the limiting of the number of delegates and members entitled to attend a Congress so as to come within the requirements of the ODT." *The Sons of the American Revolution Magazine*, Vol. XXXIX, No. 4 at p. 200 (April 1945). While not identical, the travel restrictions that lead to the cancellation of the 1945 Annual Congress are similar in nature to the current limitations on group size and social distancing found in some state governors' emergency declarations.

#### If the Trustees delegate authority to the Executive Committee, what will happen?

In the short-term, the Executive Committee will continue to work under the assumption that COVID-19 will not cancel the Annual Congress in Richmond. Notwithstanding, the Executive Committee will begin working on and finalizing plans for alternative methods to conduct the business normally required at an Annual Congress. The Executive Committee has already placed a standing teleconference call on its calendar to address these issues, while complying with the necessary notice provisions of the Bylaws. Unlike the situation faced by the Executive Committee in 1945, we have additional technology and tools available to the National Society today. Congress might look different from prior years, but the decisions will be made with the health and wellbeing of our Compatriots in mind and in compliance with the decisions of local authorities.

All that is being asked today is that the Board of Trustees delegate to the Executive Committee the authority to make the necessary decisions regarding holding the Annual Congress—and any changes to the format of an Annual Congress—that are required by the COVID-19 pandemic and related states of emergency. Specific plans will be provided as soon as it appears necessary to implement an alternative format Annual Congress.

- National HQ will open on May 18<sup>th</sup> and staff regular hours will commence on May 26<sup>th</sup>. 412 applications have been processed since the closing. Processing time has slipped from seven weeks to eight weeks.
- The SBA PPP loan has been funded. The reauthorization of the LOC has been started but will proceed in earnest in the coming week. Bank terms will become more restrictive in more likelihood.
- PG Manning will be asking all State Presidents to poll the membership of their state to determine which delegates would be attending Congress should the decision to hold Congress in person still occur. The request will have a reply back of May 29<sup>th</sup>.
- 4. Paul Callanan gave an update on the 2020 National Congress.
  - a. Registration for the Congress will be posted on or after May 29th.
  - b. If Congress is canceled a full refund would be issued and all rooms reserved under the SAR block would be canceled as well. The Governor of Virginia has a Stay at Home order in effect until June 10<sup>th</sup>.
  - c. The cancellation clause for the hotel would be a loss of approximately \$325,000. Mariott has indicated that if the Congress were held, they would waive all minimums of food & beverage and room take down.
  - d. Va Gov. Northam will permit localities maintain tighter coronavirus restrictions
  - e. It was estimated that Mariott might need 4 to 6 weeks to be able to bring the hotel back on line.
- The Executive Committee will make a decision on National Congress on May 29<sup>th</sup>. The options remain:

Invocation by Chaplain General Rev. David Felts

SG Davis Lee Wright established that we have a quorum.

Motion 1 by SG Davis Wright – That the minutes be approved as distributed. Second by Pat Niemann (FL). No discussion. Minutes were approved.

Fall Leadership Update: PG Jack Manning stated that the Fall Leadership meeting at Louisville has been canceled. There will be a virtual meeting on Saturday September 26.

#### Approval of changes to SAR Logo Contest:

Motion 2 by W. Allen Greenly, read by PG John T. "Jack" Manning – That the NSSAR Trustees replace the current SAR Symbol, that is the depiction of a Minuteman poised with a firearm held horizontally across his torso, by choosing one of the four finalists in the NSSAR New Symbol contest, such judging to take place at the NSSAR Trustee meeting to be held in conjunction with the 2020 Fall Leadership meeting, and that depictions of the four finalists be placed in a NSSAR Sharefile for review prior to the Trustee meeting. Robert Moore (HI) asked what the effective date of the newly approved logo. PG Jack Manning stated it would be almost immediately. Motion passed. Logos will be placed on the Sharefile.

#### Approval of PG appointments to fill vacancies:

PG Jack Manning announced that Darrell Hefley (OK), VPG for the South-Central District, resigned effective July 25, 2020. PG Manning stated that he would appoint Larry Stevens (TX) to the vacated position. Per earlier guidance, VPG Stevens would have the rights and duties of a Vice President General, but would not me a voting member of the Board of Trustees.

Motion 3 by PG Warren Alter – I move the Trustees approve the PG appointment of Larry Stevens (TX) as the Vice President General of the South-Central District. Seconded by Paul Callanan (MI). No discussion. Motion passed.

#### Status of application for PPP Loan forgiveness:

TG C. Bruce Pickette reported that the application has not been submitted for the PPP loan forgiveness yet. All remaining loan funds must be used by the next payroll period. We should not have any problems obtaining that forgiveness, which will be completed by August or September.

#### Update on the Line of Credit:

TG Pickette reported that the line of credit renewal process has not started with Fifth Third Bank. The bank had promised that they would attempt to arrange the processing during the month of July. We are hopeful that by the end of July, we will have it. The forms are ready to be signed.

#### Update on New Store Software:

TG Pickette reported that the Nexternal software has been implemented, went live this month and members have been ordering. We now have an on-line engraving option and the credit card processing is working. We have 3 or 4 issues to fix. A sales tax issue that should be resolved within a few days. Biggest issue appears to be a missing inventory model that would allow customer to see live inventory numbers. The Executive Committee is addressing the issue and we believe the module will be in place next week. It was also noted that this new software, in addition to tying into our accounting software, also provides a number of useful reports that were unavailable in the old Blackstone-create store.

#### Building safety, security, and maintenance items updates:

Executive Director Don Shaw stated that the building is secure and untouched. On the museum side, an internal security 30' high wall of plywood on the inside of façade was completed yesterday. It will also be used to secure the building when the facade is restored. The Glare 3M security film will be installed next Thursday, Friday and Saturday on the library windows and the lower level windows.

Looking at several options for covering the statue, without trying to bring attention to it. One option is a canvas cover, working to get a cost and how to secure in place.

Headquarters staff is back at full operations since the day after Memorial Day. Everybody is back in the building, except for the genealogists, who coordinate themselves about coming into the building and working remotely because of the six-foot spacing requirement.

Leslie Miller, a part time supplemental genealogist is leaving. GG Jim Faulkinbury asked that he be involved with the hiring of a replacement.

#### **Building Facade Restoration:**

Ken Goodson reported that the estimated cost is about \$150,000 and that the sourcing of about half the money has been identified. Most of the materials will be maintenance free. The windows on the building will all be UV coated. The doors themselves will be secured with steel plates. The doors were all sized appropriately so that Solid Light can move materials in and out. The next step is the Historical Society needs to approve the plans. Plans will be finalized next week and approval from the Historical Society could occur between 2-4 weeks after that. If Trustees can approve the plans before September, it will be possible to have this completed by Thanksgiving.

#### Approval Times for New Applications and Supplementals:

Executive Director Don Shaw stated that new are about 4 weeks and supplementals is about 19 weeks.

#### Solid Light Update:

HG Bill Stone stated that Solid light is going to need both the front entrance and the proposed large elevator in the back of the building. Looking at the timeline for finishing the museum plans, which will be about eight months and then start working on construction as the money is available. Construction is broken down into venues and galleries. Timeline is now critical. The elevator for the building provides a lot of advantages for the rooftop garden, the build out for the museum and for bringing people in and out of the building.

Kenneth Goodson noted that the elevator if approved today, it would take six or more months to be completed. It is critical for a building. Because the façade work will be specialized with many small components, many different contractors will be involved, so multiple bids will not be possible. To be able to get approval from the historical society we will have a list of each line item, it will be extremely specific and detailed.

TG Pickette stated that we are not looking to necessarily put the elevator in at this time. The first step in that elevator process is to get elevator drawing then we need to build it out. That is a separate quote that I would recommend the executive committee take up later.

PG Manning stated that we tentatively schedule August 29 for a trustees meeting if everything goes as planned with the façade plans and the historical committee.

#### Member Database Update:

James Osbourn (MO) reported that the member database team is currently working to combine three databases into one authoritative source. There is data cleanup to do and there are missing fields, conflicting fields and some misaligned data that needs to be cleaned up and the team is working with Mission Data to create a plan for how to do that in a stepwise fashion so that we don't lose anything and keep the good things that we want in place. The team is meeting weekly.

#### Other:

PG Jack Manning stated that Congress report book is now on Sharefile, and a virtual Trustee meeting has been scheduled for December 5. Spring Leadership is on March 4 to 6, 2021.

SG Wright asked that with respect to the Fall leadership, we encourage all committees to meet the week beforehand. And to reach out to the general officer and liaison, who should be able to get you either a zoom Host set up so that you can have your committee meeting or if you have a different way of meeting, that's fine too. Also stated that the SAR is looking at switching from GoToMeeting to Zoom and to have the ability to have hosting accounts for the general officers to set up for the committees that they are responsible for. VPG Larry Mylnechuk asked that with mostly peaceful protests going on around the country. Is there any public position statements that we are allowed to give regarding the SAR. PG Manning stated that we cannot involve the SAR as an organization in any direct or indirect manner.

Robert Anderson (AL) asked that with no Fall Leadership can we release the winners of the Brochure and Poster contests. PG Manning said they can release them now.

Paul Callanan (MI) asked that the members please wait to cancel because we have not officially told the hotel that we are canceling Fall Leadership. We are also trying to shift the current reservations for the Spring Leadership. We will notify everyone as soon as we know how we are going to be shifting all those reservations.

PG Warren Alter noted that a Zoom virtual candidates forum will be on the Thursday of when Fall Leadership would have been. More detail on this will be on SAR Officer. Secondly, candidates are not allowed to announce it any official meetings, such as Trustee meetings.

Rationale: Currently, the bylaws provide that amendments may be made to the bylaws solely at an "Annual Congress" while the constitution provides that amendments to the constitution may take place at any Congress. In preparing for the possibility of a virtual Annual Congress, certain General Officers have identified bylaws that require changes to effectively complete the business of an Annual Congress.\* This amendment to the constitution would allow amendments to either the constitution or the bylaws to be adopted at any Congress rather than solely at an Annual Congress.

Notice period: the bylaws currently provide a 45-day notice period for an amendment to the bylaws; this change would align the notice period for amendments to the constitution with the notice period for amendments to the bylaws.

\* The bylaws committee will consider proposed amendments to the bylaws to conduct a virtual congress at a future meeting.

Rationale: Article V of the Constitution and Bylaw 17 have been interpreted as prohibiting the organization from conducting an Annual Congress by alternative means, which in 2020 resulted in the cancellation of the Annual Congress in Richmond and an inability to conduct any of the business that was scheduled to come before that Congress. This set of amendments authorizes Congresses by alternative means. For example, if the COVID-19 pandemic is continuing in July 2021, the Seattle Congress could be conducted by alternative means.

Section 1: This amendment clarifies that the process for setting the time and location of a "Special Congress" is the same as an "Annual Congress." This amendment merely codifies existing practice.

This amendment also deletes the phrase "In an emergency" to avoid disputes over what constitutes an emergency. The circumstances that warrant a change – emergency or otherwise – are best left to the judgment of the Trustees, two-thirds of whom must agree to change the time or location of a Congress.

### Section 2: No changes.

*Section 3:* This new section defines "location" to include meetings that occur in multiple locations through the use of communications technology. It largely tracks the language of Bylaw 17, which authorizes national committees and the Board of Trustees to meet through alternative means.

"Alternative means" is limited to the use of any means of communication by which all individuals participating may simultaneously communicate with each other and which are accompanied by the capability of document sharing either in advance of or during the meeting.

"More than one member may participate through a single communications link." This sentence explicitly permits the Trustees to authorize so-called "hybrid" meetings in which many members assemble in one location while others join remotely.

This bylaw would <u>not</u> authorize remote participation in Congresses or Trustees' meetings generally. Such participation would only be permitted if the meeting were so designated by a two-thirds vote of the Trustees.

#### About the SAR Library

The SAR National Headquarters, Genealogical Research Library, and SAR Center are located at 809 West Main Street in Louisville, Kentucky.

The need to establish a Library for the National Society was recognized by the founders of the Society, who specified provisions in the Constitution for the acquisition and preservation of Revolutionary War records, documents, and relics.

From 1889 until 1926 the Society acquired 225 books. In 1926, the Society established an office in Washington, D.C. which contained the "permanent records of the Society membership and genealogical library."

In 1978 the SAR purchased the South Fourth Street building in Louisville as its headquarters. Over the next year the second floor of the building was redesigned to accommodate a fully functional Library. It opened its doors to the public on January 17, 1979, with approximately 25,000 items.

In October 2010, the Library began operations in its new facility on West Main Street. The primary focal point of the collections is the Revolutionary War era but the collection includes other materials of a genealogical nature. The library collection has grown to over 55,000 items and includes family histories, local, county and state records and genealogy materials, and access to the online databases of Ancestry, Fold3, HeritageQuest, and American Ancestors (NEHGS).

In February 2019, the SAR Genealogical Research Library was designated a FamilySearch Affiliate Library by FamilySearch International. This cooperative agreement grants our patrons access to 350+ million additional images of original records and documents. FamilySearch International is a non-profit, volunteer -driven organization sponsored by The Church of Jesus Christ of Latter-day Saints.

The Library's growth depends upon cash gifts as well as donations of family genealogies, Revolutionary War histories, county and other books and items of genealogical content. Donors should check the Library catalog to ensure the item is not a duplicate or check with the Librarian. A donor gift form is available at the Library and at Society meetings. The SAR Library is a non-circulating genealogical collection.

The Friends of the SAR Library (FOL) was organized to assist the SAR Library in implementing its collection development objectives and to provide for the purchase of non-budgeted items such as equipment, supplies and new technology. The collection objectives include those books, manuscripts, microfilms, and online services as needed to enhance and expand the current collection.

A sub-committee of the SAR National Library and Archives Committee, the Friends consists of the Librarian General, National Library and Archives Committee Chairman, Chairman of the Friends of the SAR Library, the SAR Librarian, and state-level FOL Chairmen. Membership is also open to all SAR members, state-level societies, chapters, and the general public. The state-level Society Chairman of the FOL may coordinate the donation of books, microfilms, etc., directly to the SAR Library and promote the Library within his society so that all SAR members are familiar with it and its programs.

Membership dues of the Friends of the SAR Library are distributed as follows:

- 60% goes into the Library Endowment Fund, which is the permanent fund for the
- <sup>1</sup> use of the Library, and from which the gains may only be used by the Library; and
- \* 40% goes directly to the Library Special Purpose Operating Fund.

In addition to donations of family genealogies, Revolutionary War histories, county and state histories, and other books and items of genealogical content, the SAR Library's growth depends upon cash gifts.

The additional recognition programs of the Library include:

## **Outreach Education Committee Report**

Outreach Education is focused on member services, community initiatives, program development and collaborations. Each month on average over 20 state societies receive support for chapter activities that include SAR Youth Awards, program materials and recruitment resources. The SAR Retractable Banner continues to be an effective tool at SAR booths that draw attention to chapter events. Chapters frequently request the SAR to Help Preserve A Precious Heritage, Youth Award Programs, Discover Your Family Heritage and Long May She Wave, Flag History & Etiquette. With the imminent release of the new SAR website, Outreach Education is working to make program materials more readily accessible to members and educators.

Outreach Education with its place on the board for both the Kentuckiana Cultural Consortium and the state's Arts & Cultural Alliance has increased its involvement in state-wide panel discussions, presentations and education conferences such as Southeastern Museums 2020 Conference in Louisville, Ky. Once again Outreach Education will be supporting National History Day at the state and regional competitions as judges as well as offering the popular SAR *Outstanding Early American History Award*.

- a. New interactive activities for *Making "Cents" of Colonial Currency* were developed for the elementary and middle school levels. A colonial marketplace was created where students bartered, used currency or a combination of both to buy goods offered by colonial merchants. Comparisons with colonial notes and today's one-dollar bill were identified by the student groups.
- b. Outreach Education hosted the November Kentuckiana Cultural Consortium representing organizations from across the Commonwealth in the SAR Education Center & Museum. The featured speaker was Dr. Marty Pollio, superintendent of Jefferson County Public Schools, which is the 27<sup>th</sup> largest school district in the United States.
- c. The SAR Digitization Lab located in the SAR Genealogical Research Library is in place and producing great images of documents from the SAR's institutional archives. A student intern from the University of Louisville has been hired and is now working two days a week in the lab along with a weekly library volunteer. Additional interns for the summer are being recruited to continue the digitization process.
- d. Outreach Education participated in an onsite conservation workshop focusing on the cannons located in the SAR Education Center & Museum. Scaffolding was purchased and the seven-and-a-

half foot tall Sons of Liberty 1775 statue located in front of Headquarters also received a through cleaning.

- e. A very successful Artifact Donor Program has to date contributed almost 60 objects to the SAR Museum Collection. Work is ongoing as we coordinate the necessary documentation for SAR records between the donor and Museum Board. Each of these museum quality artifacts hold a rich history that will be interpreted in the SAR Education Center & Museum.
- f. A PowerPoint presentation has been developed to create greater awareness of the Artifact Donor Program and the successful expansion of the SAR Museum Collection. Presented to local chapters by Museum Board members it highlights program specifics and the wide variety of museum quality artifacts donated to the SAR.
- g. As part of the Museum Board's ongoing Deaccession Project, deaccessed objects were prepared for consideration and individually selected by Cowan's Auctions, LLC to be sold through online auctions. Accepted objects were prepared for shipping and picked up at Headquarters by Cowan's Auctions, LLC. Notices will be sent out by the Museum Board when objects come up for auction.
- h. In November Rae Ann Sauer and Zac Distel served on the conference panel for the Kentucky Council of Archives in Kenton City, Kentucky.
- i. Local chapters from across the country continue to order the SAR Retractable Banner to increase their visibility at community events, genealogy workshops and local membership recruitment drives.
- j. Working with Wayne Snodgrass, Outreach Education has assisted in the development of a Patriot Chest data base where over 90 Patriot Chests were identified at the local chapter level. The location of these Patriot Chests and their contact information will be shared with interested educators who are seeking this interactive method of teaching Revolutionary War history.
- k. Exhibit tables promoting the SAR Genealogical Research Library were staffed at both the Louisville Genealogical Society Conference, Filson Society's Family History Day and the Ohio Valley Conference in Frankfort, KY.



#### ORDER BY THE COUNTY JUDGE OF HARRIS COUNTY

Wherens, On March 11, 2020, a Declaration of Local Disaster for Public Health Emergency was issued to allow Harris County to take measures to reduce the possibility of exposure to COVID-19 and promote the health and safety of Harris County residents; and

Whereas, on March 13, 2020, a Declaration of State of Disaster was issued by Governor Abbott to take additional steps to prepare for, respond to, and mitigate the spread of COVID-19 to protect the health and welfare of Texans; and

Whereas, the COVID-19 virus is contagious and spreads through person-to-person contact, especially in group settings; and

Whereas, the Centers for Disease Control and Prevention ("CDC") recommends an "All of Community" approach focused on slowing the transmission of COVID-19 through social distancing to reduce illness and death, while minimizing social and economic impacts; and

Whereas, due to the substantial risks to the public, the following extraordinary measures must be taken to protect the public.

NOW THEREFORE, I, COUNTY JUDGE FOR HARRIS COUNTY, TEXAS, PURSUANT TO THE AUTHORITY VESTED BY TEXAS GOVERNMENT CODE CHAFTER 418, HEREBY FIND AND ORDER:

SECTION 1. That the findings and recitations set out in the preamble to this ORDER are found to be true and correct and they are hareby adopted by the County Judge and made a part hereof for all purposes.

SECTION 2. Effective as of 8:00 a.m. on March 17, 2020, and continuing until 11:59 p.m. on March 31, 2020, unless terminated or modified by an earlier order, the County Judge of

the County of Harris, Texas, deems it in the public interest to order that:

(a) Restaurants with or without drive-in or drive-through services and microbreweries, micro-distilleries, or wineries may only provide take out, delivery, or drive-through services as allowed by law,

(b) Bars, nightclubs, lounges, tavems, or areades and private clubs shall close.

SECTION 3: That the Harris County Sheriff's Office, the Harris County Fire Marshal's Office, and other peace officers, are hereby authorized to enforce this order.

SECTION 4: Harris County will post this Order on its website. In addition, the owner, manager, or operator of any facility that is likely to be impacted by this Order is strongly encouraged to post a copy of this Order onsite and to provide a copy to any member of the public asking for a copy. If any subsection, sentence, clause, phrase, or word of this Order or any application of it to any person, structure, gathering, or circumstance is held to be invalid or unconstitutional by a decision of a court of competent jurisdiction, then such decision will not affect the validity of this order.

SECTION 5: This Order applies to all unincorporated and incorporated areas within the boundaries of Harris County.

# Leave the statues of Founding Fathers alone

Memory is a funny thing. Chances are, you still remember clearly what President Donald Trump said in 2017, after violent clashes in Charlottesville between white supremacists rallying around a statue of Robert E. Lee and leftist counterprotesters. "You had some very bad people in that group," Trump allowed at an Aug. 15 news conference, "but you also had people that were very fine people, on both sides." Almost three years on, anyone who tries to deny that Trump is a racist is apt to have those words flung back in their face.

We recall those remarks, but most of us have slowly forgotten about what else Trump said, although it was almost as controversial at the time: "So this week it's Robert E. Lee. I noticed that Stonewall Jackson is coming down. I wonder, is it George Washington next week? And is it Thomas Jefferson the week after? You know, you really do have to ask yourself, where does it stop?"

This came in for much derision. In the Washington Post, Princeton historian David Bell declared that the distinction between slavery-defending Vice President John C. Calhoun and George Washington "is not difficult to make." Jim Grossman, executive director of the American Historical Association, called the attempt to equate Confederates with Founding Fathers "absurd" and "unacceptable for the president of the United States," while Douglas Blackmon of the University

of Virginia said, "The most kind explanation of that can only be ignorance, and I don't say that to insult the president."

Three years later ... can it be? Trump looks prescient, and his critics perhaps a touch naive. The iconoclasts, having largely defeated the rebel army, are turning on the Founding Fathers. It was supposed to be trivially easy to articulate those distinctions, yet I have not seen a flurry of commentary from historians eager to educate the protesters as they schooled Trump.

Even George Washington University, whose very name constitutes an endorsement of our first president, seems to have quietly removed a bust of Washington for safekeeping after it was toppled from its pedestal, rather than loudly condemn an attack on the father of our country.

In private, most of my leftleaning friends say that Washington should stay. They don't downplay the moral catastrophe of his slave ownership, but they weigh that, as Bell advised three years ago, "against his role as a heroic commander in chief, as an immensely popular political leader who resisted the temptation to become anything more than a republican chief executive, and who brought the country together around the new Constitution." And they conclude that Washington deserves to stay in the canon of our country's heroes - deeply flawed, as most heroes are, but

still worthy of admiration for the good he did.

They'd just prefer not to have to say that out loud.

Trump is no great moral theorist, but he does have a certain cunning about human behavior, enough, possibly to foresee that the Great Statucide would proceed by what conservative writer Rod Dreher has dubbed "the Law of Merited Impossibility": Conservatives warning about the dire consequences of some social change are dismissed as hysterical cranks - and then, when exactly what they predicted eventually comes to pass, denounced as bigots for opposing the new order. Implicit in Dreher's law is an intermediate phase in which a large number of people sit

uncomfortably silent as the radicals take the moderate majority's well-intentioned efforts further than they ever dreamed.

If you had told me 10 years ago that same-sex marriage meant Christian bakers being legally required to bake cakes for same-sex weddings, I, or any supporter of marriage equality, would have dismissed this as conservative propaganda, too silly to even bother refuting.

What Trump understood, and his critics perhaps didn't, was that you cannot credibly declare that some revolution in social affairs has a natural stopping point unless you personally commit to stopping it when it goes too far.

It's not enough to say that very clear distinctions can be drawn between allowing gays to marry and forcing people to cater weddings that conflict with their religious beliefs; between the father of our country and the traitor who led a rebel army in defense of slavocracy. When the moment arrives, you have to actually draw them.

If you don't, you will cede issue after issue to the radicals. And if making those tacit concessions again and again and again, then however privately you may rue it, you will nonetheless end up with something very different from your idealistic vision. Something that looks like ... well, like the Republicans who quietly ceded their party and their conscience to Trump, one outrage at a time.

"Parents should be looking at the numbers – they're climbing," said Dr. Peter Jung, pediatrician and co-founder of Blue Fish Pediatrics in association with Children's Memorial Hermann Hospital. "We're at the point where we need to be more wary of sending kids to day care."

As of June 16, 242 cases of CO-VID-19 at 203 child care operations were reported to Texas Health and Human Services. Of

those cases, 167 were adult staff members and 75 were children.

There may still be a misconception among the public that children can't get seriously ill from COVID-19, Jung said.

"The percentage of kids who get a severe case is small and the percentage of those cases that end in death is also small," he said. "But the risk is real that they can get seriously ill." Multisystem inflammatory syndrome in children, brought on by a COVID-19 infection, can inflame the heart, lungs, kidneys, brain, skin, eyes or gastrointestinal organs, according to the CDC. It can show up to four weeks after the COVID-19 infection ends.

"It's a very serious complication that we're seeing, even in Houston," Jung said.

The risk of sending children to

"Asymptomatic people can spread the virus," he said. "Sometimes, you're just not symptomatic yet. It can be a few days before symptoms start to show and you're still very likely to spread it."

A negative test for the virus also does not necessarily mean that the patient is not incubating the virus, the doctor added. That's why it's important to follow the CDC guidelines on self-quarantining for 14 days if it's known that a patient came into contact with a confirmed case.

"Day cares are asking us to test kids, but a child should still stay cares that accept new clients.

Jung said parents should carefully vet child care centers to ensure they are following proper hygiene habits, such as good air ventilation, low room density, increased disinfection and required mask-wearing by employees.

Even if a provider follows CDC guidelines, there is no certainty that there won't be any transmissions, Jung said.

"Those measures will reduce the risk," he said. "But there's no guarantee that everything in play is safe."

They were built for precisely those reasons. They have no other possible meaning, apart from transparent euphemisms about states' rights and federal tyranny.

But the same is not true of the Jefferson Memorial in Washington, D.C., with its paeans to universal enlightenment, equality and religious freedom. It is not true of the Lincoln Memorial, a living monument that for decades has been a touchstone for the nation's freedom struggles. Ulysses S. Grant, for his part, was raised in an abolitionist family; when he received a slave from his slaveholding father-in-law, Grant immediately released him from bondage. Those who know little about Grant hold this against him. Instead, we should honor him for crushing the Confederacy and then, as president, breaking up the Ku Klux Klan, advancing the 15<sup>th</sup> Amendment and signing the Civil Right Act of 1875-the first of its kind and the forerunner of the landmark Civil Rights Act of 1964.

[No] monument to Jackson celebrates the Trail of Tears or the fact that he owned slaves. He is honored for two lasting accomplishments. As a general, he repelled a massive British invasion at New Orleans in 1815; and as president, he secured the Union by standing up to Calhoun and his militant proslavery supporters, the forerunners of the secessionist slavocracy, during the Nullification Crisis in 1832-33. Somewhere, Calhoun's shade, embittered by the decision to remove his monument in Charleston, S.C., is smiling grimly at the attacks on his greatest antagonist.

Unless we can learn from history the difference between persons who preach and practice evil and those who at best imperfectly extricate themselves from evil yet achieve great good, we might as well cease building monument to anyone or anything, and cease teaching history except as dogma.
