#### Basic, Expanded Basic, Premium by Kelly McBride, President (2006-2007)

Every organization has several types of members and each is important in their own way. Using terminology favored by cable companies we would describe those members who pay their dues, but who do not attend meetings as having a Basic level of membership.

Our chapter has approximately 50% of our members in this category. This category is important as dues, however modest, go to pay for awards used in our various programs. The next level would best described as Expanded Basic. Compatriots who favor this level of participation would consist of those who attend one or two meetings a year. These individuals have interest in the programming, but have schedule conflicts that do not permit more involvement. A review of our attendance records indicate that about 20% of our members would be here. Premium service would include those individuals who are able to make most of the meetings and who are also involved as a committee chairman or officer. The remaining 30% of our membership is here. These numbers are not surprising as the 80/20 rule is well observed. The difficulty arises when the membership is not quite large enough for the 20% to 30% of the members to carry the program load.

Thus, this is where the Robert Rankin chapter finds itself. We need some of our 50% Basic to come to our meetings and see what we have to offer and consider taking part in what we have to offer. More importantly we need more members moving into our Premium Service. We are absent a Historian and Richard Shanks, a past President, needed to step up and serve as Secretary/Treasurer. I look forward to your moving your categories from Basic to Expanded Basic to Premium.
