# Member Spotlight

Douglas W. Thornton Jr., Chaplain Elect, Robert Rankin Chapter



#### Personal:

Douglas W. Thornton (Doug) was born June, 1922 in Atlanta Georgia where he has resided for most of his life. Doug, a widower, remarried in May 2006 to Margaret Chapman, a native of Forney, Texas. He has two children, Richard an architect living in Georgia and Paula who is temporarily living in Calgary, Canada. Paula is a 25 year member of the DAR. Doug's two grand children include Laura, a junior at Texas A&M and Matt who is living with his parent in Canada. A music afficando, Doug fondly remebers a John Phillip Sousa conducting performance at the city of Atlanta auditorium featurning bands of the Bulldogs as well as the Rambling Wrecks.

#### **Educational:**

Doug is a proud graduate of the University of Georgia where he earned his BA with high honors in French. He returned to his alma mater to earn his JD. While at Georgia, Doug was a member of Phi Betta Kappa and also served as President of Omicron Delta Kappa. Although Doug is known to wear the red and black of the bulldogs often and with pride, his two children are graduates of the Georgia Institute of Technology (the Georgia Tech Yellow Jackets).

### Military:

Doug served in the Army from July 1943 until January 1946 in the 24<sup>th</sup> infantry division. He was a staff sergeant and also a

rifle squad leader. Decorations he received include the Purple Heart, Combat Infantry Badge, Asiatic Pacific Medal with three battle stars, Phillipine Liberation Medal, GCM, North American Defense Medal, and the WWII Victory Medal. He was wounded July 4<sup>th</sup> 1945; the end of the Southern Pacific campaign was July 5, 1945. He was in a general hospital when he heard the news of the surrender of Japan on August 15<sup>th</sup>.

#### Professional and Volunteer:

Most of Doug's working career was as an accountant with Ralston Purina. In 1957 he bacame Secretary/Treasurer of Scott Huggins Realty and Mortgage, a joint venture partner of Tramell Crow in Georgia. From 1972 until his retirement in 1984, Doug worked for the State of Georgia as Departmental Budget Officer. He served as Vice President of Samaritan Together of Clayton Co., Georgia and was founder and and served for seven years as a Director of Operation Jobs.

#### Genealogical:

Doug joined the Marquis d' Lafayette Chapter of the Georgia Society of the SAR in 1998. He subsequently transferred to Piedmont Chapter in Alpharetta, Georgia and then to the Rankin Chapter in 2007. Doug has been nominated for the position of Chaplain of the Rankin Chapter for the 2008 – 2009 year. His ancestor is John Morell II, a French Huguenot. Morell was a Captain in the Georgia militia and served as President of the Council of Safety in Savannah, Georgia. Both his father and his brother signed an oath of allegiance to the British Crown and were both lost at sea.
