Single or Double occupancy is \$89.00 per night. Hotel room rates are subject to applicable state and local taxes (currently 13%) in effect at the time of check-in. In the event a guest wishes to cancel a reservation, the deposit is refundable if notice is received before 48 hours prior to the day of arrival and a cancellation number is obtained. We are obligated to pay First Presbyterian Church for the exact number of meal reservations we guarantee based on compatriot reservations. Dear President Harcourt:

This letter transmits to you the latest (the Fourth) revision of our SAR Chapter By Laws containing the already approved insert of new Article IV relative to the death, resignation, incapacity and removal of Chapter Officers.

I have included in this Fourth Amended And Restated By Laws several new, added or interlined provisions to make the By Laws more complete and usable as an authoritative reference and guide to virtually all issues likely to arise in Chapter affairs. Mostly all such added items serve to clarify prior-approved provisions rather than to introduce new or different principles or standards to be observed. However to be entirely safe in the obtaining of required membership approval of the revised package, I recommend taking advantage of the previously-approved Article VII (governing amendments) to bring before the membership at the next or at an early regular membership meeting, and without prior notice (except as a meeting Agenda item) a request for membership approval of the revised package.

Should you (the Executive Committee) choose to ask for membership approval, I will be glad (The Good Lord willing) to be present to explain the package and to move its approval.

This revision project was properly assigned to me (as Chapter Chancellor) during your Presidency and we hoped to have it concluded on your watch. However, due to illnes and the press of priority work, I did not conclude the project until today. Accordingly, I am of a mind that you, as the immediate past President, may wish to also conclude efforts to obtain final membership approval of the package and then present it to the Chapter (making multiple copies for the purpose) for quidance now and on into the future.

Please do consult with President Parese as to how this matter will be handled so that you and he can determine timing matters and an appropriate Agenda item.

New Subject: Since a family decision has been made to move Mrs. Burnham and me to the Houston, Texas area (the Woodlands) next May or June, I must resign my Office as Chapter Chancellor effective the last day of February, 2006. Accordingly the Executive Committee should begin its collec-

tive duty to identify a successor Chancellor. The By Laws provide guidance for this effort.

On a personal note, George, your leadership as Chapter President has been inspiring and expremely effective in revitalizing the Chapter both in its growth of membership and in its achievement of its several Patriotic endeavors. On behalf of myself as well as of all Chapter members, I hereby render to you a very smart SALUTE! We all wish you well and send you our profound thanks.
