# WASHINGTON AT MT VERNON

After the revolutionary war ended and General Washington resigned his commission he looked forward to the relaxed atmosphere of Mt Vernon. He would work, rest and enjoy the life of the country squire with Martha. He had served with no salary however he was reimbursed for his expenses.

On his arrival at Mt Vernon admiring visitors started showing up at his door. With the stream of guests so unrelenting that a year and a half passed [550 days] before he and Martha could dine alone. Visitors were always invited to dine with them and spend the night. There were politicians, painters, foreigners, solders that he had served with, all of the famous names of the time etc. He wrote the names in his squire's diary. It was a steady stream and at times he had to buy cattle and other food items because Mt Vernon could not produce enough to feed them.

The costs were outrunning his income & financial situation became precarious. He was land wealthy but cash poor. He rejected a plan by officials of Pennsylvania to petition the Continental Congress for money on his behalf. He made a greater sacrifice by turning down grants of land that congress was awarding other Revolutionary War veterans.

When asked to serve as Americas first president he again refused to accept pay but would accept an expense account to cover his living expenses and entertaining that had become a burden.

As he was preparing for his trip to New York he applied for a loan of on thousand pounds to pay off his debts and was refused. He appealed to an acquaintance for 5 hundred pounds and stopped in Philadelphia to see financier Robert Morris for the remainder. Morris had established the first US Bank with capital of four hundred thousand dollars; fifty thousand of his own money.

When he reached New York for his inauguration he must have been relieved that this burden was lifted. However he could not have imagined the rough road ahead as the first President of the United States.

# SPOTLIGHT ON SAN ANTONIO CHAPTER COMPATRIOT

This month's Spotlight Compatriot is a native of Mississippi who attended prep school at the Marion Institute. At 17 he joined the Army parachute troops - the 11th Airborne and with them saw action in the Pacific, Philippines and the Japanese occupation. Upon returning home he went to Old Miss where he married his wife, now of 59 years. They had a daughter who provided three grandchildren - and now 2 great-grandsons. The family went to west Texas as our Compatriot was employed by Humble Oil and Refining Company. Following that they moved to Corpus Christi where our man worked as a consultant in the oil business. Then it was to Washington. D.C. where he was the Assistant Executive Director of the American Geology In-

stitute. In the years 1971 - 1986 he was at the University of Texas in Austin, retiring as the assistant vice-president of research. From that post he became President of Live Oak Energy - which he later sold; yet to this day remains active every business day as a petroleum consultant. His motto is, "the older I get the more I charge". He was appointed by Billy Clayton to the Texas Committee on Marine and Coastal Commission dealing with international protocols of oil and gas and international boundaries. His father was SAR and his mother was SAR. He has served as the president of the Patrick Henry chapter, editor of the TXSSAR publication, TXSSAR vice president and TXSSAR president. Beyond those offices he has been the President of Colonial Wars, Governor of the San Antonio Colony of the Mayflower, founding president of the San Antonio chapter of the Sons of the Confederacy, Governor of the San Antonio Company of the Jamestown Society. He and his wife are members of St. Marks Episcopal Church. They look forward to seeing you at the TXSSAR convention in March (the last time the state convention was held in San Antonio our spotlight compatriot was the chairman!)

## COMPATRIOT OBITUARY

Calvin Marion Inman, born July 25, 1924 in Numa, Iowa, passed away January 27, 2007 in San Antonio, Texas. He was preceded in death by his parents, Miles and Cleo Inman, and two sisters, Agnes Semroska and Margaret Johnson. He is survived by his wife, Mary Hollan Inman; also three nieces and four nephews and their spouses: Milesa and Sam Quraini, Brenda and Lynn Davis, Jana and John Eng, Dan and Mary Johnson, Roger and Kitty Johnson, Brad and Brenda Johnson, Jeff and Connie Johnson; seventeen great-nieces and nephews; several cousins, and many dear friends. At an early age Cal moved with his parents to Ardmore, South Dakota where he grew up and graduated from high school with the Class of 1942. His college education at South Dakota State was interrupted by World War II. He served for almost three years in the South Pacific and occupation of Japan with the 24th Division, 13th Field Artillery. After his discharge, he returned to college and received his BA degree with the Class of 1950. Later that spring he headed for Texas. His first job was with Gonzales Warm Springs Foundation. He also worked a number of years for National Life and Accident Insurance Company before beginning the teaching career he loved. He taught journalism and was sponsor of the school yearbook and newspaper at Holmes High School in the Northside ISD for 21 years. Cal and Mary loved to travel and were able to visit most of the places in the world they wanted to see. They built a cabin in the Black Hills of South Dakota near Mt. Rushmore and spent at least a part of every summer there.
