DONATIONS TO SERVE VETERANS AT AUDIE MURPHY VETERANS MEMORIAL MEDICAL CENTER

Because of the Coronavirus (COVID -19), all Veteran Service Organizations have cancelled their services to the VA Volunteer Services Office (VAVS) at the Audie Murphy Veterans Memorial Medical Center in San Antonio. As a reminder our Chapter provides a two-person team to operate the Popcorn Concession each Friday where we receive donations for each bag of popcorn we "sell". These donations average about \$600 per month. These monies go into a Veterans Service Account that supports the personal needs of hospitalized veterans and all other veterans who receive health care services in the South Texas Regional Health Care System.

Because of the loss of these revenues since March, several of our chapter members have made voluntarily donations to the VAVS so they can continue meeting the needs of these patients. To date, over \$1920.00 has been donated. To continue these donations, chapter members are invited to make voluntary donations until our Popcorn Concession can be reactivated – possibly in the Fall. As stated in the March - April Chapter Newsletter we noted that Candace Landrum from East Central High School had advanced to the Texas Society State Oration Contest. Because the State Meeting was moved from April to July 30th — August 2nd due to the coronavirus pandemic, the State Contest was conducted via a video presentations. In early May, Landrum was selected as the Texas Society Oration Contest Winner. Accordingly, she was to compete in the National Society Oration Contest during the Annual Congress in Richmond, VA in July. However, with the coronavirus pandemic still affecting many communities across the nation,

Miss Mary Eleanor Brackenridge, the 1st Regent and Founding Member of the San Antonio de Bexar Chapter! (**Photo at Right**) Shown from left to right are Past Regent Peggy Jared, Regent Karen McCloskey, most recent Past

Regent Lauren Walthour, Past Regent Sandy Burton (now current Treasurer). The Chapter celebrated its 118th Anniversary of the founding of the Chapter having been organized on December 11, 1902.

Past Regent Peggy Jared gave a sterling overview of the many accomplishments of Miss Brackenridge who contributed in many ways to the growth of San Antonio.

The Tribute in part reads: "Miss Brackenridge was a staunch supporter of education—especially for women. She even delayed moving to Texas with her parents to



graduate in 1855 from Anderson's Female College in Indiana at the age of 17. Upon arriving in Texas, Miss Brackenridge ministered to family and friends and even studied medicine in order to serve her new area which had much sickness but few physicians. Miss Brackenridge became a highly visible and influential leader in an educational movement which coincided with "the wonderful awakening of women to sense their responsibilities" during the late 19th and early 20th centuries. She personally provided the financial means for many women to receive higher educations, including those which emphasized medicine. A 1905 article published in the DAR's American Monthly Magazine stated that, while under the leadership of Miss Brackenridge, the San Antonio de Bexar Chapter donated to the San Antonio Industrial School for African American Girls, thus promoting DAR's support of and dedication to Education. In her zeal to provide more opportunities for women, Miss Brackenridge was instrumental in establishing the State College of Industrial Arts for Women in Denton, Texas, now known as Texas Women's University. Under her leadership, the San Antonio de Bexar Chapter also provided financial support to that institution. Miss Brackenridge and two others were the first women to serve on a board of regents at an institution of higher education in Texas. TWU, as it is often called, still honors Miss Brackenridge's contributions with the Student Union Building being named in her honor. Today, we thank Miss Mary Eleanor Brackenridge for her immense contributions to education."

WREATHS ACROSS AMERICA (WAA) EVENT HELD AT SAN ANTONIO NATIONAL CEMETERY



Each December on National Wreaths Across America Day, our mission to Remember, Honor and Teach is carried out by coordinating wreath-laying ceremonies at Arlington National Cemetery, as well as at more than 2,100 additional locations in all 50 U.S. states, at sea and abroad. PASSING OF COMPATRIOT HENRY GARCIA, IR.

April 27, 1938 -December 14, 2020

Henry Andrew Garcia, Jr. joined the Lord on December 14, 2020 in San Antonio, Texas. He was born in 1938 in Refugio, Texas to Henry Andrew Garcia, Sr. and Mary Cisneros. Henry was preceded in death by his son, Henry "Hank" Garcia. He is survived by his beloved wife of 62 years, Betty Vogel Garcia; daughter, Lawna D. Swellander (Stephen); son, Greg Garcia (Melissa); sisters, Sara Valenzuela and Theresa Garcia; brother, Basil Garcia; seven grandchildren - Sarah, Dylan, Kendrik, Michael, Brian, Alexandria, and Emily; and four great-grandchildren Corrine, Collin, Cason, and Harlynn. Henry was a wonderful son, broth-



er, husband, father, Opa/Grand Opa, and Patriot. A dedicated Kelly AFB teammate, successful business/food entrepreneur, committed community volunteer, proud Sons of the American Revolution life member, involved Canary Island descendant, active Los Bexarenos Genealogical and Historical Society member, a world-class softball pitcher and coach, and an accomplished speaker, writer, and reporter. "Living on Love, Borrowing on Time" was Henry and Betty's song. Henry had a presence larger than life, and will be greatly missed.

A private Graveside Service is planned. Everyone is invited to sign the online guestbook at www.missionparks.com in the Tributes section.

Note: On November 1, 2014 Henry was inducted as a member of the San Antonio Chapter, Sons of the American Revolution. Henry was a Life Member and served admirably as Chairman of the Membership Committee constantly working to keep members in an "Active Status" and in good standing in the Texas Society and National Society. He was awarded the SAR Meritorious Medal and Certificate posthumously on December 17, 2020. He will be dearly missed.

PRELIMINARY TREATY OF PARIS IS SIGNED

On this day in history, November 30, 1782, the preliminary Treaty of Paris is signed, bringing the hostilities of the American

Revolution to a close. The British government became more disposed to achieving peace with the Americans after the surrender of General Charles Lord Cornwallis and the loss of several of its possessions to France and Spain.

The United States was prevented from dealing directly with Great Britain due to its alliance with France, having promised that it would not negotiate with Britain without them. Nonetheless, messages were exchanged between Ben Franklin in Paris and Prime Minister, Lord Shelburne's peace commissioner in Paris, Richard Oswald, seeking common ground on which a preliminary peace could be formed.

The United States demanded full recognition by Britain as a sovereign nation, removal of British troops from its territory and fishing rights off Newfoundland. At first, Britain wanted the United States to remain as British possessions, but with greater autonomy. This was rejected by Ben Franklin, who wanted all of Canada for the United States as part of the deal. Britain rejected this proposal.

The negotiations continued in secret and John Jay and John Adams joined Franklin. Due to the exposure of some secret meetings between Britain and France and to his distrust of the French, John Jay, began negotiating directly with the British, against the wishes of Franklin and unbeknownst to France. Formal talks began in September and the remaining difficulties were ironed out over the next two months.

Two days after America's 4th peace commissioner, Henry Laurens, arrived, a preliminary agreement was signed on November 30, 1782, which recognized the United States and established its boundaries, roughly being from the Mississippi to the Atlantic and from the Great Lakes to Florida. The preliminary Treaty of Paris also granted the US the right to fish off Newfoundland and granted both Britain and the US the right to use the Mississippi River.

Congress was to "earnestly recommend" to the states that they refund any property taken from Loyalists during the war and creditors on both sides were given full rights to recover all debts. Prisoners were to be released on both sides and all American property was to be left undamaged by British troops when they left.

The preliminary Treaty of Paris was ratified by Parliament on January 20, 1783 and by Congress on April 15. A ceasefire was declared by Britain on February 4 and by America on April 11th. The final official Treaty of Paris was signed by the commissioners on September 3, 1783, ratified by Congress on January 14, 1784 and by Great Britain on April 9, 1784. The ratified documents were exchanged once and for all in Paris on May 12, 1784, bringing the American Revolution to an end. http://www.revolutionary-war-and-beyond.com
