DONATIONS TO SERVE VETERANS

Because of the Coronavirus (COVID -19), all Veteran Service Organizations have cancelled their services to the VA Volunteer Services Office (VAVS) at the Audie Murphy Veterans Memorial Medical Center in San Antonio. As a reminder our Chapter provides a two-person team to operate the Popcorn Concession each Friday where we receive donations for each bag of popcorn we “sell”. These donations average about \$600 per month. These monies go into a Veterans Service Account that supports the personal needs of hospitalized veterans and all other veterans who receive health care services in the South Texas Regional Health Care System.

Because of the loss of these revenues since March, several of our chapter members have made voluntarily donations to the VAVS so they can continue meeting the needs of these patients. To continue these donations, chapter members are invited to make voluntary donations until our Popcorn Concession can be reactivated – possibly in the Fall. Any amount will help – maybe \$50 or more. CHAPTER YOUTH AWARDS (CONTINUED)


Our Chapter Winners for the **Joseph S. Rumbaugh Oratorion Contest** were video recorder and selected on January 16, 2021. The winners were:

MEMORIAL RESOLUTION FOR COMPATRIOT COLONEL ALBERT C. METTS, JR. USA (RET)

WHEREAS, The hand of death on 4 February 2021 entered our ranks and removed from our midst, COMPATRIOT ALBERT CASWELL METTS, JR., our venerable and esteemed brother in arms, and

WHEREAS, COMPATRIOT METTS was born on 24 April 1921 at Clarksville, Coahoma, Mississippi. He was the son of Albert Caswell Metts and Gladys Marie Oliver, whose ancestors founded our nation. COMPATRIOT Metts resided in San Antonio, Bexar, Texas. A memorial service was held for him on 5 March 2021. Following which, his earthly remains were placed at eternal rest at the Sunset Memorial Park Cemetery in San Antonio, Bexar, Texas, and

WHEREAS, by virtue of the proven patriot service during the Revolutionary War of his ancestor Lieutenant Rueben Long of the Virginia line who served from 26 September 1776 until final Victory, and

WHEREAS, COMPATRIOT METTS successfully proved his direct lineage from the above patriot, and was admitted to membership in the National Society, Sons of the American Revolution on 27 April 1981 as member number 118709 and simultaneously was granted membership in the Texas Society, Sons of the American Revolution, member number 4699, and

WHEREAS, COMPATRIOT METTS was an active member of the San Antonio Chapter of the Sons of the American Revolution, and during that 39 year period participated in the activities of the chapter, thereby contributing to its success, and having served as Honorary Chapter President since 2010. Compatriot Metts' service to SAR has been recognized by his having received the War Service Medal, Meritorious Service Medal, Texas Centennial Medal, Silver Good Citizenship Medal, Bronze Good Citizenship Medal, TXSSAR Bronze Service Medal, and

WHEREAS, COMPATRIOT METTS was also an active member of the Magna Charta Barons, the Plantagenet Society, the Military Order of the Crusades, the Society of Colonial Wars, the National Society of the American Colonists, the General Society of the War of 1812, the Jamestowne Society, the Family of Bruce Society in America, the San Antonio Genealogical and Historical Society, King and Queen County (VA) Historical Society, Callaway Family Association, Overall Family Association, Order of Washington, the Sovereign Colonial Society-Americans of Royal Descent, Colonial Order of the Crown, the Sons of Confederate Veterans, the Order of the First Families of Mississippi, and the First Families of Tennessee through all of which he promoted patriotism and honor, and

WHEREAS, COMPATRIOT METTS graduated from the United States Military Academy at West Point, and was during his lifetime a professional Army Officer, having retired after 33 years with service in the Second World War, Korea and in Vietnam, was recognized for exemplary service with a Silver Star, the Legion of Merit with Oak Leaf Cluster, the Bronze Star, and numerous additional Commendations, and

WHEREAS, COMPATRIOT METTS was preceded in death by the lovely Betty Metts who so graciously served her community and ancestors with years of service to the DAR and CAR, and is survived by his loving and devoted children and grandchildren, and

WHEREAS, upon his death, our country and state lost a loyal citizen whose devotion never faltered. He was one of the most zealous and faithful defenders of the principles for which our patriotic ancestors fought in the battle against the British for American Independence. In his quiet and unassuming way he did much to promote the progress and development of his country and the happiness of those around him. He was a good, quiet and modest person and enjoyed the respect, esteem and admiration of all who knew him.



MEMORIAL RESOLUTION FOR COMPATRIOT ALBERT C. METTS, JR. (CONTINUED)

NOW, THEREFORE BE IT RESOLVED by the San Antonio Chapter, Texas Society, Sons of the American Revolution as follows:

FIRST: That this chapter has lost a loyal and devoted member. To his family and friends we express our thanks for sharing his life with us and extend our profound condolences at his passing from our ranks.

SECOND: That this country and state have lost an honorable, upright and honest citizen, who was always ready to spend his life and give his service for that which he believed to be right and for the best interests of his country and state. To that end we dedicate ourselves anew to the continuance of the service to the country which his lifetime so well performed. We further Resolve that we are pledged again to cherish, maintain and extend the institutions of American freedom, to foster true patriotism and love of country, and to aid in Securing for mankind the blessings of Liberty

THIRD: That for the purposes of perpetuating the memory of his life and fidelity to the purposes of the Sons of the American Revolution, and his steady devotion to duty, duplicate copies of this Resolution shall be entered into the minutes of this chapter, which he loved so well, and delivered to his family. The Resolution will also be read to chapter members attending a regular monthly meeting and will be displayed on the chapter Internet web page. The Resolution may also be submitted to the Texas Society for publication in a future edition of The Texas Patriot, its magazine.

FOURTH: That a duplicate of this Resolution shall be bound together with other similar Memorial Resolutions of the San Antonio Chapter, Texas Society, Sons of the American Revolution into a minimum of three books.

Copies of this book will be donated to:

1. The San Antonio Public Library,
2. The Library of the National Society, Sons of the American Revolution in Louisville, Kentucky,
3. Chapter Genealogist, San Antonio Chapter, Sons of the American Revolution.

FIFTH: As a token of our love and respect for our Compatriot, we have purchased a suitable book on the American Revolution or about one of its many patriots. That book will be donated to a local Public School Library in San Antonio with an inscription referencing COMPATRIOT ---- METTS.

CONFEDERATION CONGRESS APPROVES NEW CONSTITUTIONAL CONVENTION

On this day in history, February 21, 1787, the Confederation Congress approves a new Constitutional Convention to be held at Philadelphia beginning on May 14, 1787. The Articles of Confederation, which was the first governing document of the United States, had proved to be too weak for the government to function effectively.

Some of its weaknesses included that each state had one vote, regardless of size, giving disproportionate power to small states; Congress could not regulate interstate and foreign commerce, making it easy for states to undercut each other on import/export prices; there were no federal courts and no president; to pass a law, there had to be a 2/3 vote of the states; changes to the Articles required a unanimous vote; and Congress had no power to tax or raise money. It could only ask the states for money, and they usually didn't pay.

Calls for changes to the system were made for years, but early in 1786, the state of Virginia requested that all the states get together at Annapolis, Maryland to come up with suggestions for changes to the Articles regarding matters of trade and commerce. The Annapolis Convention met from September 11 to 14, but with delegates present from only five states, New York, New Jersey, Delaware, Pennsylvania and Virginia. Four other states had appointed delegates, but they failed to arrive on time, while four others didn't even appoint delegates.

The delegates, including Alexander Hamilton, James Madison and John Dickinson, all agreed that major changes were necessary to the Articles regarding trade, but there were so few representatives present that they didn't feel they had the authority to act. Instead, they put together a proposal to Congress and the states that all thirteen states should meet the following May to make serious amendments to the Articles of Confederation that would permanently remedy its weaknesses.

Congress received the proposal and, though there were great differences between the members about how far the changes should go, they passed a resolution on February 21, 1787 that stated, "It is expedient that on the second Monday in May next a Convention of delegates who shall have been appointed by the several States be held at Philadelphia for the sole and express purpose of revising the Articles of Confederation."

The Convention met in May and, rather than modifying the Articles of Confederation, came up with an entirely new governing document – the Constitution of the United States, which took effect on March 4, 1789.
